RECOMMENDATION: Recommend approval of a Resolution awarding a Contract for the Woody Invasive Plant Clearing Project - Buckthorn Eradication Initiative at Middlefork Savanna Forest Preserve (Phase 2B) to Clean Cut Tree Service in the Contract Price of \$120,970.75.

STRATEGIC DIRECTIONS SUPPORTED: Conservation; Leadership

FINANCIAL DATA: The projects discussed below were approved as part of the adopted FY 2022 Budget. The total cost of implementing all projects was estimated in the Budget at \$205,000.00.

The actual cost of the project to be completed under the contract that would be approved by the attached resolution is \$120,970.75. The bids under \$30,000.00 that do not require Committee recommendation and Board approval will be accepted by staff and total \$28,924.90. The actual cost of all projects totals \$149,895.65.

Funding for a portion of the project is being supplied by the National Fish and Wildlife Foundation Chi-Cal Grant Fund. This portion of the project, \$36,516.33, will be charged to the Middlefork Savanna Pilot Buckthorn Eradication Grant Fund, (69644100-803200-61104) and \$113,379.32 will be charged to account 20104100-803200-61104.

BACKGROUND: Invasive plants are a significant challenge to habitat conservation. Management of invasive plants is necessary to improve and conserve habitat quality and species diversity on District properties throughout Lake County. The District conducts removal of invasive woody species as part of a Land Management Program to restore and enhance woodlands, savannas, prairies and wetlands to increase the health, diversity, and sustainability of flora and wildlife populations and to restore or enhance ecosystem services.

In 2019, the District applied for and received funding from the National Fish and Wildlife Foundation's Chi-Cal Rivers Fund Grant for projects to remove invasive wood species. This grant opportunity provides funding for work in the Chicago and Calumet River Watersheds in the Chicago Region. With the awarded funds, the District will provide a cost-share program to interested landowners, which provides 50% of the project cost to remove buckthorn from their property. The landowners are responsible for the remaining 50%.

The District advertised for bids for multiple clearing projects within and near Middlefork Savanna Forest Preserve, each indicated as a separate Project under one consolidated bid process. Each project has its own Scope of Work and Specifications. Some projects include land adjacent to Middlefork Savanna that is owned by others, who have signed consents to allow removal work on their property and to participate in the cost-sharing program. Work includes all labor, equipment

and materials to selectively remove invasive woody trees and shrubs and thin select native species, and includes disposal services and follow-up selective herbicide applications.

The projects were advertised on August 11, 2022 and four bids were received. A summary of the lowest bids received and recommended for approval is listed below:

Staff recommends that Clean Cut Tree Service be awarded a contract as the lowest responsible bidder for the project areas for which it was the low bidder (Project Areas A, B, H, I, K, M1 and M7).

Staff will award a contract to Native Restoration Services, for the project areas for which it was the lowest bidder (Project Areas C, E, F, J, L, M4, M5, M6, N and O).

Work is anticipated to begin December 15, 2022 and to be completed June 30, 2023.

A RESOLUTION AWARDING A CONTRACT FOR THE WOODY INVASIVE PLANT CLEARING PROJECT - BUCKTHORN ERADICATION INITIATIVE AT MIDDLEFORK SAVANNA FOREST PRESERVE (PHASE 2B)

WHEREAS, the Lake County Forest Preserve District (the "District") has advertised in <u>The Lake County News Sun</u> for sealed bids for the Woody Invasive Plant Clearing Project – Buckthorn Eradication Initiative at Middlefork Savanna Forest Preserve (Phase 2B) (the "Work"); and

WHEREAS, all sealed bids were received and opened by the District at its General Offices, 1899 West Winchester Road, Libertyville, Illinois on September 2, 2022 at 11:30 a.m. local time; and

WHEREAS, the District's staff, the Purchasing Manager, the Director of Natural Resources, and the Operations Committee have reviewed the bids and recommend that the Board of Commissioners (i) finds that Clean Cut Tree Service, Inc., is the lowest responsible bidder for the Work in Project Areas A, B, H, I, K, M1, and M7 (collectively, the "Clean Cut Work") and (ii) awards a contract for the Clean Cut Work to Clean Cut Tree Service, Inc., in the contract price of \$120,970.75 (the "Contract"); and

WHEREAS, the Board of Commissioners hereby finds that Clean Cut Tree Service, Inc. is the lowest responsible bidder for the Clean Cut Work;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:

Section 1: Recitals. The recitals set forth above are incorporated as a part of this Resolution by this reference.

Section 2: Acceptance of Bids. The bids for the Clean Cut Work submitted by Clean Cut Tree Service, Inc., in the total amount of \$120,970.75 (the "Contract Price") are hereby accepted and a Contract for the Clean Cut Work is hereby awarded to Clean Cut Tree Service, Inc.

<u>Section 3:</u> <u>Execution of Contracts.</u> The Executive Director of the District is hereby authorized and directed to execute the Contract for the Work in the amount of the Contract Price.

<u>Section 4: Payments.</u> The Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.
