FINANCIAL DATA: No financial impact.

BACKGROUND: Under the bylaws of the Foundation, as amended on May 25, 2023, Directors of the Preservation Foundation are elected to a three-year term of service and approved annually by the Voting Members at the Annual Member Meeting.

The Foundation's bylaws state the number of Directors should be between ten (10) and twenty-five (25) members and should include two Lake County Forest Preserve District Commissioners, as appointed by the President of the Forest Preserves. The bylaws also state the Forest Preserve Executive Director shall be an ex-officio member of the Preservation Foundation Board of Directors with voting rights.

The Board of Directors approves a list of candidates, which may include additions to or deletions from the recommendations of the Board's Executive Committee, if any. The Board of Directors submits its approved list of recommended candidates to the Voting Members for election at the next Annual Member Meeting.

RECOMMENDATION: Recommend a resolution recommending approval of the 2024 Preservation Foundation Budget and Fundraising Plan

FINANCIAL DATA: The total estimated revenue and expenditures for 2024 are \$8,002,000.

<u>BACKGROUND</u>: Under the bylaws of the Preservation Foundation of the Lake County Forest Preserves, as adopted on May 7, 2007, an annual Budget and Fundraising Plan must be submitted for approval to the Foundation Voting Members.

On July 10, 2019, the Lake County Forest Preserves Board of Commissioners approved a resolution authorizing staff to work with the Board of the Preservation Foundation to establish an endowment fundraising goal of \$20 million by December 31, 2025. On August 14, 2019, the Foundation Board approved a resolution adopting this fundraising goal. Adopting this goal defined a clear north star for the Preservation Foundation and guides the work of the Development Division staff.

The proposed revenues and expenditures included the 2024 Preservation Foundation Budget, as well as the goals and objectives defined in the 2024 Fundraising Plan, were developed as part of the 2024 Annual Budget for the Lake County Forest Preserve District, which was approved by the Lake County Forest Preserves Board of Commissioners on October 11, 2023.

2024 Fundraising Goals and Activities

Executive Summary:

As the charitable partner of the Lake County Forest Preserves, the Preservation Foundation raises unrestricted funds, funding for projects and programs, and endowed funds to extend and accelerate the work of the District.

The Forest Preserves 100-year vision serves as the north star for the Foundation's efforts, and our larger strategy is driven by the objectives defined in the Road Map to 2025. The goals and objectives outlined in the 2024 Preservation Foundation plan focus on three tactics identified in the Road Map:

- Ensure Financial Stability: ensure a permanent source of revenue for tree planting, reforestation and habitat restoration through charitable financial support in the amount of \$20 million.
- Strengthen Connections: increase countywide awareness of the Preservation Foundation from 16% (2019 survey results) to 32%.
- Strengthen Connections: increase the donor base from 4,600 to 9,200.

Strategic Goals

Goal 1: Secure \$20,000,000 in endowment funds by December 31, 2025 to ensure a permanent source of revenue for tree planting, reforestation and habitat restoration.

Current state:

- 2022 Actual: \$4,621,282.47

As of October 19, 2023: \$6,068,437

2024 Objectives:

- Host an evening event on May 17, 2024 for 250 guests to launch the public phase of Every Acre Strong campaign.
- Solicit remaining principal and major gift prospects to the campaign by December 31.
- Support PF Board and Committee members in their efforts to identify 5 10 prospects in their networks willing to support the endowment campaign with a gift of any size.
- Work with Forest Preserve leadership to identify and leverage District support of the endowment campaign, such as Concerts in the Plaza.

Goal 2: increase countywide awareness of the Preservation Foundation from 16% (2019 survey results) to 32% by December 31, 2025.

Current state:

2022 Attitude & Interest Survey: 26% of respondents reported somewhat (17%) or very familiar (9%).

2024 Objectives:

- Develop 30 engagement opportunities, such as hosting events and participating in Forest Preserve activities.
- Enable new Major Gift Manager to swiftly connect with existing and prospective donors to increase Guardian Society membership from 161 in 2022 to 190 in 2024.
- Support the work of the new Community Engagement Specialist role and help the Forest Preserve gain new volunteers.
- Complete production of and begin publicizing the Preservation Foundation film.

Goal 3: Increase the donor base from 4,600 to 9,200 by December 31, 2025.

Current state:

- 2022 Actual: 5,520

- As of October 31, 2023: 5,872

2024 Objectives:

- Implement a robust annual giving strategy utilizing cross-channel marketing that highlights the impact of giving to acquire 1,000 new donors.
- Secure \$200,000 in unrestricted funds through mailings, digital campaigns, and personal outreach.
- Secure \$800,000 for Forest Preserves projects or programs by leveraging prospects' existing areas of connections with the District.
- Develop clear giving opportunities to support "lightly restricted" funds such as General Natural Resources, General Operations & Infrastructure, and General Education, educating potential donors on how they can provide a flexible source of funding to an area of the Preserves that is important to them.

Goal 4: Improve the infrastructure and fundraising capacity of the Preservation Foundation.

2024 Objectives:

- Provide materials, conduct training, and support the efforts of the Preservation Foundation and Committee members to serve as ambassadors for the Foundation.
- Recruit, train, and engage 3 to 5 new board or committee members to help raise awareness of the Preservation Foundation and secure financial support.
- Working with Foundation leadership, create a plan to manage changes in membership and leadership as board terms expire.
