# BOARD OF COMMISSIONERS LAKE COUNTY FOREST PRESERVE DISTRICT – REGULAR MAY MEETING MINUTES MAY 14, 2025

The Board of Commissioners of the Lake County Forest Preserve District met on Wednesday, May 14, 2025 at the District General Offices, 1899 West Winchester Road, Libertyville, Illinois.

- **1.0** Call to Order President Jessica Vealitzek called the meeting to order at 9:00 a.m. and confirmed electronic attendance for Commissioners Marah Altenberg, Sara Knizhnik, and Mike Danforth, all due to employment.
