Warning of Risk

The District is committed to conducting its recreation programs and activities in a safe manner and holds the safety of participants in high regard. The District continually strives to reduce risks and insists that all participants follow safety rules and instructions that are designed to protect the participant's safety. However, participants and parents/guardians of minors participating in a recreational activity must recognize that there is an inherent risk of injury or death when choosing to participate in any recreational activity and programs connected with or associated with this Beach Pass.

You are solely responsible for determining if you or your minor child/ward are physically fit and/or skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult your physician before undertaking any physical activity.

Recreational activities are intended to challenge and engage the physical, mental and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury or death when participating in any recreational activity. Understandably, not all hazards and dangers can be foreseen. Depending on the particular activity, participants must understand that certain risks, dangers and injuries due to acts of God, inclement weather, slipping, falling, inadequate or defective equipment, failure in supervision or instruction, poor skill level or conditioning, carelessness, horseplay, premises defects and all other circumstances inherent to indoor and outdoor recreational activities/programs exist. In this regard, it must be recognized that it is impossible for the District to guarantee absolute safety.

Important District and Beach Rules and Regulations

- ❖ All swimmers under the age of 12 years must be accompanied by an adult, guardian or other responsible person, at least 16 years of age. No unattended youth allowed in the locker rooms, please.
- ❖ There are no inflatable balls or rafts, beach or soccer balls, noodles, kickboards, water wings, or otherwise unauthorized flotation devices allowed. These items could give a false sense of security to a swimmer and create an unsafe situation. However, we are happy to provide you with a United States Coast Guard approved lifejacket; please ask a staff member to lend you one for your visit.
- ❖ Swimming in street clothing is not allowed; please wear proper swim attire. Also, only approved Swim Diapers are allowed. Approved Swim Diapers are available for purchase at our concessions area.
- ❖ No alcoholic beverages are allowed on the Beach. Forest Preserve staff may request to check coolers prior to entry to the Beach.
- ❖ No glass items or bottles are allowed on the Beach; Forest Preserve staff may request to check coolers prior to entry to the Beach.
- ❖ Independence Grove reserves the right to remove any participant(s) from water activities based on behavior.
 - * No breath-holding or "Dare" games are allowed.
 - * Throwing of sand, weeds or rocks is prohibited.
 - * Diving is prohibited.
 - * No climbing on guard chairs.
 - * Swimmers must remain within the designated swim area.
 - * Patrons who repeatedly violate written or verbal safety procedures will be removed from the Beach.
- ❖ Swimming may be restricted or prohibited under the following conditions:
 - *poor water quality *overcrowding *darkness *lightening/thunder *behavior violations
- ❖ Swimmers will be expected to respond to warnings of lake and/or weather conditions that may be communicated by Independence Grove staff via whistle, warning siren or other notification.
- ❖ Participants must bring emergency situations to the attention of the facility lifeguards, who will be the first responders for all rescue and/or first aid issues.

The Lake County Forest Preserve District requires your cooperation when using our facilities to help maintain our Preserves for the benefit and enjoyment of everyone.
