RECOMMENDATION: Recommend approval of a Resolution awarding a Three-Year Contract to CDW-Government, Inc. (“CDW-G”), for Cybersecurity Detection and Response Services, in an amount not to exceed \$221,880.00.

STRATEGIC DIRECTION SUPPORTED: Organizational Sustainability

FINANCIAL DATA: The contract price is \$73,960.00 annually, totaling \$221,880.00 over the three-year life of the Contract. These services are budgeted in the FY2025 budget, in fund 19224000-701400.

BACKGROUND: Over the last four years, the District has experienced attack attempts on its IT network. While most of these attacks have been thwarted by existing safeguards, there have been instances where attempts have gained a foothold in the network. During those events, viruses were manually tracked and removed from machines, and data was restored from backup, or recreated, causing downtime for departments and a duplication of work. After each situation, the IT division reviewed and tightened security on the network. However, there is still a risk of unplanned access to the District network resources.

The contract with CDW-G would provide additional cybersecurity through DarkTrace, with email, cloud, and a network defense system. This contract will enhance the District’s cyber-threat monitoring, with active autonomous response, which can intercept and neutralize cyber-attacks, including insider threats, ransomware, and Internet of Things (IoT) attacks, without the need for human intervention. Leveraging artificial intelligence (AI) and machine learning is necessary to keep pace with today’s advanced persistent threats. DarkTrace reduces cyber risk and provides protection, alerts, and response across the entire digital environment.

Under the Governmental Joint Purchasing Act (30 ILCS 525/2), any governmental unit may purchase supplies or services jointly with other government agencies, provided that the price for the supplies or services being purchased were obtained through a competitive bidding or proposal process initiated by a government agency. The City of Mesa, Arizona, through Omnia Partners, has publicly advertised for, and received, competitive bids for cybersecurity services and has awarded a contract to CDW-G

as Contract 2024056-01 (the “City of Mesa Contract”). The City of Mesa Contract provides that other units of local government may also enter into contracts with CDW-G on the same terms. Staff determined that the DarkTrace cybersecurity services are available from CDW-G under the City of Mesa Contract.

**A RESOLUTION AWARDING A THREE-YEAR CONTRACT TO
CDW-GOVERNMENT, INC., FOR CYBERSECURITY DETECTION
AND RESPONSE SERVICES**

WHEREAS, the Lake County Forest Preserve District (the “District”) desires to purchase cybersecurity detection and response services (the “Services”); and

WHEREAS, the Director of Administration and the Purchasing Manager have determined that the Services require personal confidence; and

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act, 30 ILCS 525/1, et seq., any governmental unit may purchase personal property, supplies, and services jointly with one or more other governmental units if one of the governmental units has publicly advertised for, and received, competitive, sealed bids or proposals, and has awarded a contract for such personal property, supplies, and services to the lowest responsible bidder or the highest ranking proposer, all in accordance with such Act; and

WHEREAS, the City of Mesa, Arizona, through Omnia Partners, (the “City of Mesa”) has publicly advertised for, and received, competitive proposals for the Services, including a proposal by CDW-Government, Inc. (“CDW-G”); and

WHEREAS, the City of Mesa has awarded contract #2024056-01 for the Services to CDW-G, as the highest-ranking proposer for the Services (the “City of Mesa Contract”) and the City of Mesa Contract provides that other units of local government may also enter into contracts with CDW-G, on the same terms as provided in the City of Mesa Contract; and

WHEREAS, it is in the District’s best interest to award a contract for the Services to CDW-G on the same terms as provided in the City of Mesa Contract (the “Contract”);

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois **THAT**:

Section 1: Recitals. The recitals set forth above are incorporated as part of this Resolution by this reference.

Section 2: Award of Contract. The proposal submitted by CDW-G, in the amount of \$221,880.00 (the “Contract Price”) is hereby accepted, and the Contract is hereby awarded to CDW-G.

Section 3: Execution of Contract. The Executive Director of the District is hereby authorized and directed to execute the Contract for the Services in the amount of the Contract Price.

Section 4: Payments. The District Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.

Section 5: Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.


