Public Safety Monthly Report

<u>Alarms</u>

• Officers responded to multiple activated burglar alarms at Stevenson House, Countryside, Van Patten, Prairie Stream, Brae Loch, Independence Grove and Fox River. Officers are working with Facilities Department and the alarm company to locate the issues.

Animal Complaints

- Officers checked out a report of an aggressive animal at Lakewood DEA. A small pit bull/ terrier mix had attacked several animals at the DEA, but did not bite. The owner removed the animal.
- Officers responded to Prairie Wolf DEA for the report of a dog versus dog bite report. The complainant's dog received an injury to its ear.
- Officers responded to several reports of dog attacks at Grant Woods. Officers located the animal and turned it over to animal control. Officers investigated the incidents and located the owner. Officers cited the owner for multiple violations.
- Officers received a delayed report of a jogger that had received a bite from a dog at Hasting Lake. Officer completed and submitted paperwork to animal control.
- Officers received a delayed report of a dog vs. dog bite at Lakewood DEA. Report taken and paperwork submitted to animal control.

Arrests/Citations

- Officers cited two men for Indecent Exposure and lewd activities at Van Patten.
- Officers arrested a woman at Prairie Wolf DEA for Obstructing a Peace Officer and Battery after she became uncooperative with the officer while discussing a permit violation. She refused to identify herself and pushed the officer while trying to get into her car and leave.

- Officers assisted rescue on the Des Plaines River Trail north at Independence Grove with and injured bicyclist. Rescue transported him for treatment.
- Officers assisted rescue with a driver at near Rollins Savanna after she complained of dizziness and blurred vision. Rescue transported the driver for treatment.
- Officers assisted rescue at Countryside Golf Club after a person choked on hot dog. Rescue transported the injured person.
- Officers assisted rescue at Lakewood with a Civil War re-enactor who injured their knee. Victim transported by rescue for treatment.
- Officers assisted rescue at Independence Grove on an unresponsive visitor who suffered a diabetic episode and received treatment on the scene.
- Officers located a woman at Old School who had become overheated while riding a bicycle. Officer provided transportation home for the woman.
- Officers assisted Vernon Hills Police at Wright Woods searching for a suicidal subject. Officers located the subject. Rescue transported the subject for treatment.
- Officers assisted rescue at Van Patten with a man having a stroke. Rescue transported the victim.
- Officers assisted the Lake County Sheriff at Buffalo Creek and Heron Creek searching for a suicidal subject. Person located and complaint is unfounded.
- Officers assisted rescue at Duck Farm Dog Exercise Area, person having difficulty breathing; victim transported by Rescue.
- Officer assisted rescue with combative homeless man at Greenbelt; Subject subdued and transported to hospital by Rescue.
- Officer assisted rescue at Independence Grove with a man suffering from heat related issues; Rescue transported victim.
- Officers responded to a bicycle accident on the footbridge at Hastings Lake. Two bicyclists ran head on into each other. Rescue transported both riders for treatment.
- Officers responded to an accident at Rte. 132 and O'Plaine Rd. involving a District vehicle.

Encroachments

- Lakewood- Neighbor has multiple citations for ongoing encroachments. The District installed post and cable fencing to prevent any further encroachments onto District land.
- Rollins Savanna- Four adjoining properties were found to have gardens and other encroachments.
- Pine Dunes- Neighboring gravel driveway has migrated onto District property.
- Middlefork Savanna- A wood chip trail has been created connecting a private residence to the District trail. Repeat violation.
- Grassy Lake- Mowing, plantings, and other improvements made on District property.
- Almond Marsh- Mowing District property. Repeat violation.
- Pine Dunes- Driveway encroaches onto District property.

Service Calls/ Crime Reports

- Officers issued Courtesy Notices to bicycle riders at Grassy Lake.
- Officers received a report of ATVs driving on the property north of Roberts Road at Fox River. Officer did not locate any ATVs and will maintain an extra watch.
- Officers located several juveniles riding ATVs at Nippersink. Juveniles were turned over to their parents and the issue is resolved.
- Officers checked a suspicious subject at Rollins Savanna who had been reported as screaming and acting strange. Officers spoke to the subject and he stated that he was singing along with music on his car stereo.

- Officers received multiple ATV and mini-bike complaints on the Millennium Trail between Rollins Savanna and Fourth Lake.
