SUBJECT: 2015-2016 Agricultural Drain Tile Investigations

RECOMMENDATION: Recommend approval of a Resolution awarding a contract for the 2015-2016 Agricultural Drain Tile Investigations to Hey and Associates, Inc., Volo, Illinois, in the Contract Price of \$99,060.00.

BACKGROUND: The purpose of this project is to identify drain tiles and drainage systems in order to facilitate current management as well as future planning and restoration efforts. Drain tile investigations are necessary to identify locations and assess the condition and functionality of aging drain tiles and drainage systems within artificially drained lands. The investigations will occur across approximately 3,500 acres of current and former agricultural land at the following sites: Grant Woods, Waukegan Savanna, Lakewood, Van Patten Woods, Pine Dunes, Edward L. Ryerson Conservation Preserve, Lyons Woods, Kestrel Ridge and Ray Lake Forest Preserves.

A request for proposals was sent to two professional service contractors skilled in this type of investigation. A summary of the lowest quotes received is listed below:

A RESOLUTION AWARDING A CONTRACT FOR THE 2015-2016 AGRICULTURAL DRAIN TILE INVESTIGATIONS TO HEY AND ASSOCIATES, INC.

WHEREAS, the Lake County Forest Preserve District (the "District") desires to purchase agricultural drain tile investigation services at Grant Woods, Waukegan Savanna, Lakewood, Van Patten Woods, Pine Dunes, Edward L. Ryerson Conservation Area, Lyons Woods, Kestrel Ridge and Ray Lake Forest Preserves (the "Services"); and

WHEREAS, the Director of Natural Resources and the Purchasing Manager have determined that the Services require personal confidence; and

WHEREAS, the Purchasing Manager has solicited proposals for the Services; and

WHEREAS, the District's staff; the Purchasing Manager; the Director of Natural Resources; the Planning and Restoration Committee; and the Finance and Administrative Committee have reviewed the proposals and recommend that the Board of Commissioners (i) find that the proposal submitted by Hey and Associates, Inc., be determined to be the proposal that is most advantageous to the District; and (ii) award a contract for the Services to Hey and Associates, Inc., (the "Contract") in the amount of \$99,060.00 (the "Contract Price"); and

WHEREAS, the Board of Commissioners hereby finds that the proposal for the Services submitted by Hey and Associates, Inc., is the proposal that is most advantageous to the District, and that the Contract Price is fair and reasonable; and

WHEREAS, the District has a satisfactory relationship with Hey and Associates, Inc., for agricultural drain tile investigation services;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois THAT:

Section 1. Recitals. The recitals set forth above are incorporated as a part of this Resolution by this reference.

<u>Section 2</u>. <u>Award of Contract</u>. The Contract in the amount of the Contract Price, in substantially the form attached hereto, is hereby awarded to Hey and Associates, Inc.

<u>Section 3</u>. <u>Execution of Contract</u>. The Executive Director of the District is hereby authorized and directed to execute the Contract for the Services in the amount of the Contract Price.

<u>Section 4</u>. <u>Payments</u>. The District Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.

<u>Section 5</u>. <u>Effective Date</u>. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
