**RECOMMENDATION:** Recommend approval of a Resolution awarding a Contract for the Oak Woodland Restoration Project; Phase I Woody Invasive Plant Control at Captain Daniel Wright Woods Forest Preserve to Clean Cut Tree Service, Inc., Grayslake, Illinois, in the Contract Price of \$143,100.00.

BACKGROUND: Captain Daniel Wright Woods contains some of Lake County's highest quality natural areas and oak ecosystems. Oaks are considered a keystone species in the Chicago region, and play a critical role in maintaining the structure of the woodland community, providing food and shelter for many species. Unfortunately, oak seedlings and saplings in our woodlands are not receiving enough sunlight to thrive. Without action now, oak woodlands in Lake County and the Chicago region will not survive in the long term. This woodland habitat restoration project will encourage the growth of oak and other native saplings by selectively removing trees and shrubs to open up the canopy to increase light reaching the ground level. These thinning efforts will allow future generations of oaks to mature, allow for reintroduction of native shrubs and other native ground-layer species, rebuilding a sustainable woodland habitat for the future.

The goal of this project is to promote oak regeneration across 54 acres of Oak Woodland and Northern Flatwood communities by removal of invasive brush and selective removal of trees of varying sizes within Captain Daniel Wright Woods. Work will include mechanical and hand cutting, girdling, brush pile burning, loading and hauling large tree trunks, selective wick herbicide application to cut stumps, and follow-up herbiciding of non-oak resprouts.

The project was advertised on July 9, 2015 and 6 bids were received. A summary of the bids received is listed below:

Staff recommends that Clean Cut Tree Service, Inc., be awarded the contract as the lowest responsible bidder. Work is anticipated to begin November 15, 2015 and be completed by July 30, 2016.
