Invasive Plant Control Phase II at Cuba Marsh Forest Preserve

RECOMMENDATION: Recommend approval of a Resolution awarding a Contract for Invasive Plant Control Phase II at Cuba Marsh Forest Preserve to Inland Landscape Group, Wauconda, Illinois in the Contract Price of \$128,825.00.

BACKGROUND: Cuba Marsh Forest Preserve is a 781-acre preserve consisting of large habitats of prairie, wetland, shrubland, and woodland communities. A wide diversity of plants and animals are found here, including several that are listed by the Illinois Department of Natural Resources as Species in Greatest Need of Conservation. Past habitat restoration efforts included as Phase I focused on invasive woody plant control on the western ¹/₃ acreage of the Preserve. This Phase II contract focuses invasive woody plant control within the centrally-located 75 acres of the preserve, where high quality prairie and wetland remnants occur.

The project was advertised on September 10, 2015 and four bids were received. A summary of the bids received is listed below:

Staff recommends that Inland Landscape Group be awarded the contract as the lowest responsible bidder. Work is anticipated to begin December 15, 2015 and be completed by July 31, 2016.
