SUBJECT: Policy Direction Regarding the Disposition of District Buildings

<u>REQUEST</u>: Policy direction requested on whether to maintain, improve, replace, or remove certain District-owned buildings.

BACKGROUND: Staff has been reviewing and analyzing the use and condition of all District-owned buildings. Each building listed on the attached spreadsheet has a current use; however, the circumstances surrounding the current use of the existing building are not clear for the long term. Based on the particular circumstances related to each building, staff's recommendation for direction on each building's future fall into three basic categories:

- Maintain Recommend status quo for use and continued basic funding for maintenance.
- Improve/Replace Recommend investments be made to improve or replace the building to support its current or intended use.
- Remove Recommend removal when current use ceases.

REASON FOR REQUEST: Policy Direction is requested.
