## AN ORDINANCE ADOPTING RULES OF ORDER AND OPERATIONAL PROCEDURES

**WHEREAS**, the Lake County Forest Preserve District (the "District") is authorized by Section 8 of the Downstate Forest Preserve District Act to adopt all necessary ordinances, rules, and regulations for the management of its property and the conduct of its business, 70 ILCS 805/8, and pursuant to such authority the District has adopted Rules of Order and Operational Procedures regarding District Board meetings, committees, finances, property, and other matters; and

**WHEREAS**, on December 5, 2016, the President of the District appointed a Rules Committee for the purpose of reviewing and recommending modifications to the District's Rule of Order and Operational Procedures; and

**WHEREAS**, the Rules Committee met on December 8, 2016 to review the Rules of Order and Operational Procedures for December 2016 through December 2018 and recommends adoption of this Ordinance, including the Rules of Order and Operational Procedures attached hereto;

**NOW, THEREFORE, BE IT ORDAINED**, by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, THAT:

**Section 1: Recitals.** The recitals set forth above are incorporated as a part of this Ordinance by this reference.

**Section 2: Approval of Rules of Order and Operational Procedures.** The Rules of Order and Operational Procedures attached hereto are hereby approved.

**Section 3:** Effective Date. This Ordinance shall be effective upon its passage and approval in the manner provided by law.
