RECOMMENDATION: Recommend approval of a Resolution Awarding a Contract for the purchase and installation of four Intellipak Compressors at the General Offices to The Trane Company, Willowbrook, Illinois, in the amount of \$39,232.00.

STRATEGIC DIRECTION SUPPORTED: Organizational Sustainability

FINANCIAL DATA: Installation of the four Intellipak Compressors at the General Offices was funded as part of the Board approved FY2016-2017 CIP Budget of \$350,000 for Facility and Infrastructure Improvements. The project was estimated at \$42,000 and the actual cost of \$39,232.00 will be charged to account 11104100-803200-60022.

BACKGROUND: The equipment will replace existing rooftop compressors that are required to condition and cool the General Offices. The existing compressors have failed due to their age and usage.

Pursuant to the Illinois Governmental Joint Purchasing Act, 30 ILCS 525/1, et seq., any governmental unit may purchase personal property, supplies, and services jointly with one or more other governmental units if one of the governmental units has publicly advertised for, and received, competitive bids or proposals and has awarded a contract for such personal property, supplies, and services to the lowest responsible bidder or highest ranking proposer, all in accordance with this Act. The Cooperative Purchasing Network (TCPN) has publicly advertised, and received competitive proposals for the equipment and services and has awarded a contract to The Trane Company, Inc., the highest ranking proposer, and has made the Contract available to other public entities through The Cooperative Purchasing Network (TCPN). The Contract allows for a 6% discount off the list price of Equipment and Installation resulting in a price of \$39,232.00 for the Equipment and Installation.

A RESOLUTION AWARDING A CONTRACT FOR COMPRESSOR REPLACEMENTS TO THE TRANE COMPANY

WHEREAS, the Lake County Forest Preserve District (the "District") desires to enter into a contract to purchase and install four Intellipak Compressors (the "Compressors") for the General Offices (collectively, the "Services"); and

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act, 30 ILCS 525/1, et seq., any governmental unit may purchase personal property, supplies, and services jointly with one or more other governmental units if one of the governmental units has publicly advertised for, and received, competitive sealed bids or proposals and has awarded a contract for such personal property, supplies, and services to the lowest responsible bidder or highest ranking proposer, all in accordance with such Act; and

WHEREAS, The Cooperative Purchasing Network (TCPN) has publicly advertised, and received, competitive proposals for the Services, has awarded a contract (the "TCPN Contract") to The Trane Company, Inc., as the highest ranking proposer for the Services, and has made the TCPN Contract available to other public entities through The Cooperative Purchasing Network (TCPN); and

WHEREAS, the TCPN Contract allows for a 6% discount off the list price of the Compressors resulting in a price of \$39,232.00 for the Services; and

WHEREAS, it is in the best interest of the District to award a contract for the Services to The Trane Company pursuant to the terms of the TCPN Contract (the "Contract") and the District is authorized to do so pursuant to the Governmental Joint Purchasing Act, 30 ILCS 525/0.01 et seq. and the Intergovernmental Cooperation Act 5 ILCS 220/1 et seq; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois THAT:

<u>Section 1</u>. <u>Recitals</u>. The recitals set forth above are incorporated as a part of this Resolution by this reference.

<u>Section 2</u>. <u>Award of Contract</u>. The bid submitted by The Trane Company in the amount of \$39,232.00 (the "Contract Price") is hereby accepted and a Contract for the Services is hereby awarded to The Trane Company.

<u>Section 3</u>. <u>Execution of Contract</u>. The Executive Director of the District is hereby authorized and directed to execute the Contract for the Services the amount of the Contract Price.

<u>Section 4.</u> <u>Payments</u>. The Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.
