# A RESOLUTION EXTENDING THE CONTRACT WITH SENTRY SECURITY LLC FOR DISTRICT-WIDE FIRE AND SECURITY ALARM MONITORING, MAINTENANCE, REPAIR AND TESTING SERVICES

WHEREAS, on March 10, 2015 the Lake County Forest Preserve District (the "District") awarded a contract to Sentry Security LLC for District-wide Fire and Security Alarm Monitoring, Maintenance, Repair and Testing Services, which has been amended by change orders 1, 2, 3, and 4 (the "Contract"); and

WHEREAS, the Contract authorizes the District to extend the Contract for an additional one-year term commencing April 1, 2017 and lasting through March 31, 2018, and the District desires to do so (the "Extension"); and

WHEREAS, pursuant to the Contract, the District may extend the Contract for two additional one-year terms, the first being April 1, 2018 through March 31, 2019 and the second being April 1, 2019 through March 31, 2020 (the "Future Extensions");

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois THAT:

<u>Section 1</u>. <u>Recitals</u>. The recitals set forth above are incorporated as part of this Resolution by this reference.

Section 2. Approval of Extension. The Extension is hereby approved.

<u>Section 3.</u> <u>Execution of Contract; Future Extensions.</u> The Executive Director and Secretary of the District are hereby authorized to execute and attest to the Extension on behalf of the District. The Executive Director is hereby authorized to approve the Future Extensions on behalf of the District.

<u>Section 4.</u> Payments. The District Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
