**RECOMMENDATION:** Recommend approval of a Resolution approving an Intergovernmental Agreement with the Illinois Department of Transportation (IDOT) for construction of a portion of the Millennium Trail and the transfer of land at McDonald Woods Forest Preserve as part of the proposed relocation of U.S Route 45 and the Millburn Bypass project.

**STRATEGIC DIRECTIONS SUPPORTED:** Leadership, Public Access and Connections

**FINANCIAL DATA:** By including the work now as part of IDOT's overall road improvement project, the District's local cost share for the shared-use path and the sidewalk portion of the project will be 20% of the total construction costs. The District's local share is estimated to be \$14,105.00. In June 2016, the Finance and Administrative Committee approved a recommendation that the local cost share be funded with the compensation received from IDOT for the conveyance of District property needed for the road improvement project, which should more than cover those costs.

**BACKGROUND:** In 2009, IDOT and the Lake County Division of Transportation began planning for the long-term improvement needs for U.S. Route 45 from Illinois Route 132 (Grand Avenue) to Illinois Route 173, with a more recent focus on the improvements needed for the Grass Lake Road and Millburn Road intersections in the vicinity of McDonald Woods Forest Preserve. District staff has been in regular contact with IDOT regarding the proposed roadway improvements and the potential impacts to District property.

As part of the planned improvements, IDOT will construct a western bypass for U.S. Route 45 that will pass through the eastern portion of McDonald Woods and include a 10-foot wide shared-use path on the west side and a sidewalk on the east side of the new road corridor. A portion (4,320 feet) of the proposed shared-use path will become an extension of the Millennium Trail from McDonald Woods north to Independence Boulevard (north of the Millburn Historic District). Improvements to Grass Lake Road include extending the shared-use path on the south side of the road, west to McDonald Woods with a connection to the recently completed Grass Lake Road underpass. Future improvements to U.S. Route 45 will extend the Millennium Trail north to Ethel's Woods and Raven Glen Forest Preserves and the District's planned underpass north of Miller Road.

In November and December 2015, the Land Preservation and Acquisition Committee, the Planning and Restoration Committee and the Finance and Administrative Committee gave staff policy direction to negotiate an intergovernmental agreement with IDOT, pursuant to which the District would convey to IDOT either an easement or fee simple interest in District land for the improvements (the "District

Land"). In June 2016, the Planning and Restoration Committee provided additional policy direction authorizing the execution of a Letter of Intent (LOI) between IDOT and the District that identified the cost sharing responsibilities for each partner agency to be allocated by jurisdiction. The LOI provides that the District's local cost share responsibility includes the costs of constructing of the shared-use path adjacent to McDonald Woods, 50% of the costs of constructing the sidewalk adjacent to McDonald Woods, and the long-term maintenance responsibilities for only the portion of the shared-use path adjacent to McDonald Woods.

The attached resolution approves an intergovernmental agreement that (i) sets forth the agencies' cost sharing and maintenance obligations regarding the proposed shared-use path and sidewalk, (ii) provides that IDOT may not undertake the U.S. Route 45 bypass until IDOT has acquired the District Land, and (iii) IDOT will construct a detention facility, in accordance with plans approved by the District, that is improved with native plants. The attached resolution also authorizes the District President and her designees to approve the future conveyance of the District Land.

Once the shared-use path associated with IDOT's project is complete, the District will complete a 0.2-mile section of the Millennium Trail connecting the existing McDonald Woods trails to the relocated U.S. Route 45, which is part of the approved Capital Improvement Plan for FY2018/19. IDOT is currently estimating a late fall 2017 start of construction for their road realignment project.

## A RESOLUTION APPROVING AN INTERGOVERNMENTAL AGREEMENT WITH THE ILLINOIS DEPARTMENT OF TRANSPORTATION REGARDING THE U.S. ROUTE 45 RELOCATION AND MILBURN BYPASS PROJECT

**WHEREAS**, the Lake County Forest Preserve District (the "District") owns property that is adjacent to U.S. Route 45 in Lake County, Illinois, known as the McDonald Woods Forest Preserve (the "Preserve"); and

WHEREAS, the Illinois Department of Transportation (the "IDOT") has the statutory responsibility for the planning, construction, operation and maintenance of the State of Illinois' highways, including U.S. Route 45; and

**WHEREAS**, the District has issues of common interest with IDOT to provide a safe means of travel for pedestrians and cyclists along State highways; and

**WHEREAS,** IDOT has proposed road improvements to U.S. Route 45 that include the relocation of Route 45 from Country Place to north of Independence Boulevard and construction of related median, storm water, and other road improvements, and a shared-use path (the "Path") and sidewalk that are adjacent to the Preserve (the "Project"); and

**WHEREAS**, the District desires that a portion (4,320 feet) of the Path be constructed and serve as a portion of the District's Millennium Trail, and

WHEREAS, the District staff has negotiated an Intergovernmental Agreement between the District and IDOT in the form attached hereto (the "Agreement") pursuant to which (i) the District would pay a local share of the costs of construction of the portions of the Path and sidewalk adjacent to the Preserve, which shares are currently estimated at \$14,105.00; and (ii) the District would maintain that portion of the Path adjacent to the Preserve; and

**WHEREAS**, in conjunction with the Project, IDOT is requesting that the District convey to IDOT fee simple interest in a portion of the Preserve to be used for the Project (the "Land Conveyance"); and

**WHEREAS**, pursuant to Section 10 of Article VII of the Illinois Constitution of 1970, units of local government and the State may contract or otherwise associate among themselves in any manner not prohibited by law or ordinance; and

**WHEREAS,** pursuant to the Intergovernmental Cooperation Act, 5 ILCS 220/1 et seq., any power, privilege, function, or authority exercised by a public agency, including the District and IDOT, may be exercised, combined, transferred, and enjoyed jointly with any other public agency to the extent not prohibited by law;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois THAT:

<u>Section 1</u>. <u>Recitals</u>. The recitals set forth above are incorporated as a part of this Resolution by this reference.

<u>Section 2</u>. <u>Approval of the Agreement</u>. The Agreement is hereby approved in substantially the form attached hereto. The President, Executive Director and Secretary of the District are authorized and directed to execute and attest to the Agreement, in substantially the form attached hereto, and whatever other documents are necessary to effectuate such Agreement.

<u>Section 3.</u> Approval of Land Conveyances. The District President is hereby authorized to approve and execute plats of dedication, deeds, agreements and any other documents necessary to make the Land Conveyance to IDOT, and to cause other District officers and employees to approve and execute such documents, after such documents have been reviewed and approved by the District's Corporate Counsel, provided that IDOT pays to the District the fair market value of any land conveyed to IDOT pursuant to the Land Conveyance.

<u>Section 4</u>. <u>Effective Date</u>. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.

#### **AGREEMENT**

This Agreement entered into this \_\_\_\_\_\_day of \_\_\_\_\_\_\_\_\_, 2017 A.D., by and between the STATE OF ILLINOIS, acting by and through its DEPARTMENT OF TRANSPORTATION, hereinafter called the STATE, and the LAKE COUNTY FOREST PRESERVE DISTRICT of the State of Illinois, hereinafter called the DISTRICT.

#### WITNESSETH:

WHEREAS, the STATE, in order to facilitate the free flow of traffic and ensure safety to the motoring public, is desirous of constructing approximately 7,200 feet of realigned US Route 45 (Milburn Bypass) to be known as FAP Route 344, STATE Section 39R, STATE Job No.: C-91-424-12, State Contract Number 60T75.

The project is composed of a new roadway (US Route 45 Bypass) from Country Place on the south to 1,500 feet north of Independence Boulevard. Relocated US Route 45 will be a four lane roadway with curb and gutter and barrier median. Grass Lake Road will be widened and re-aligned to tie into Milburn Road at existing US Route 45. A new signalized intersection will be formed with re-aligned US Route 45 and re-aligned Grass Lake Road. The traffic signals at the intersections of existing US Route 45 with Milburn Road and Grass Lake Road will be removed and replaced

with stop sign control. Approximately 1,200 feet north of Country Place, existing US Route 45 will "tee" into the US Route 45 Bypass creating a new intersection on the south. On the north, existing US Route 45 will end at a cul-de-sac north of Independence Boulevard. The project includes all other work necessary to complete the IMPROVEMENT (as defined below) in accordance with the approved plans and specifications; and

WHEREAS, for the STATE to construct the US Route 45 Bypass, it must first acquire from the DISTRICT, for public right of way and detention, the portions of McDonald Woods Forest Preserve generally depicted on the attached Exhibit A as "Future Hwy 45 ROW" and the "Subject Property" for a purchase price equal to the fair market value of the Subject Property.

WHEREAS, the DISTRICT requests that the STATE include in its contract the construction of (i) concrete sidewalk on the east side US Route 45 Bypass along the frontage of McDonald Woods Forest Preserve (generally depicted as the "Planned 5' Sidewalk" on the attached Exhibit A) and (ii) a 10' wide shared use path on the west side of US Route 45 Bypass along the frontage McDonald Woods Forest Preserve (generally depicted as the "Planned 10' Shared Used Path" on the attached Exhibit A) (the portions of such sidewalk and path along the frontage of McDonald Woods Forest Preserve are referred to in this Agreement collectively as the "IMPROVEMENT"); and

WHEREAS, the STATE has agreed to the DISTRICT's request; and

WHEREAS, the DISTRICT is desirous of said IMPROVEMENT in that same will be of immediate benefit to the DISTRICT, and its residents and will be permanent in nature.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties hereto agree as follows:

- The STATE agrees to make the surveys, obtain all necessary rights of way, prepare
  plans and specifications, receive bids and award the construction contract, and
  furnish engineering inspection during construction, for the IMPROVEMENT and
  agrees to cause the IMPROVEMENT to be built in accordance with the approved
  plans, specifications and contract.
- The STATE agrees to pay for all right of way, construction and engineering cost, subject to reimbursement by the DISTRICT and other local agencies, as hereinafter stipulated.
- It is mutually agreed by and between the parties hereto that the estimated cost and cost proration for the IMPROVEMENT is as shown on Exhibit B attached hereto and made a part hereof.
- 4. The DISTRICT has passed an annual appropriations ordinance that appropriates sufficient funds to pay its share of the cost for the IMPROVEMENT estimated to be Fourteen Thousand One Hundred Five Dollars (\$14,105.00), a copy of which is attached hereto as Exhibit C and made a part hereof.

The DISTRICT agrees that upon award of the contract for the construction of the IMPROVEMENT, the DISTRICT will pay to the STATE, in a lump sum from any funds allotted to the DISTRICT, an amount equal to 80% of its obligation incurred under this AGREEMENT, and will pay to said STATE the remainder of the obligation (including any non-participating costs on FA Projects) in a lump sum, upon completion of the IMPROVEMENT, based upon final costs.

- The DISTRICT further agrees to the full extent permitted by law, to pass a
  supplemental ordinance to provide necessary funds for its share of the cost of this
  IMPROVEMENT if the amount appropriated in Exhibit C proves to be insufficient to
  cover said cost.
- 6. Upon final field inspection of the IMPROVEMENT and so long as relocated US Route 45 from Country Place Road to North of Independence Boulevard is used as a STATE Highway, the STATE agrees to maintain or cause to be maintained the median, the through traffic lanes, the left-turn lanes and right turn lanes, and the curb and gutter, stabilized shoulders and ditches adjacent to those traffic lanes and turn lanes.
- 7. The DISTRICT further agrees to continue its existing maintenance responsibilities on all side road and driveway approaches within McDonald Woods Forest Preserve under its jurisdiction, including all left and right turn lanes on said approaches, up to the through edge of pavement of relocated US Route 45. Drainage facilities, if any, at the aforementioned approaches located within the STATE right-of-way shall be the joint maintenance responsibility of the STATE and the DISTRICT unless there is an agreement specifying different responsibilities. The STATE grants the DISTRICT the

right to enter the U.S. Route 45 right-of-way to perform its maintenance obligations pursuant to this Section and Section 8 below.

- 8. After final field inspection and approval by the STATE of the IMPROVEMENT, the DISTRICT agrees to assume responsibility for the administration, control, reconstruction and maintenance of the shared use path along the frontage of McDonald Woods Forest Preserve (estimated at 1,545 linear feet) not otherwise carried on State structures. The sidewalk on the east side of US Route 45 Bypass along McDonald Woods Forest Preserve will be maintained by the Village of Lindenhurst. The DISTRICT further agrees to indemnify and hold harmless the State, its officers, employees, and agents from any and all claims, lawsuits, actions, costs, and fees (including reasonable attorney fees and expenses) of every nature and description arising from, growing out of, or connected with any claim that the DISTRICT negligently operated or maintained the shared use path along the frontage of McDonald Woods Forest Preserve to the full extent of the DISTRICT's additional insured insurance coverage.
  - If, in the future, the STATE adopts a roadway or traffic signal improvement on US Route 45 Bypass which requires modification, relocation or reconstruction to said shared use path along the frontage of McDonald Woods Forest Preserve then the DISTRICT hereby agrees to be financially responsible for its proportionate share of costs to modify, relocate or reconstruct said shared use path in conjunction with the STATE's proposed improvement.
- The STATE shall not, and shall not allow its contractors, to commence construction
  of the US Route 45 Bypass until the PROPERTY ACQUISITION has occurred. After
  the PROPERTY ACQUISITION, and in conjunction with its construction of US Route

45 Bypass, the STATE shall (i) construct a detention facility ("DETENTION POND 2") and plant native trees, shrubs, grasses, and forbs within the SUBJECT PROPERTY, all in accordance with State Contract No. 60T75 approved plans and (ii) upon completion of DETENTION POND 2, provide maintenance and monitoring in accordance with Sections 5-400 to 5-400.10 of the Illinois Department of Transportation, Bureau of Operations Maintenance Policy Manual as applicable.

- 10. The DISTRICT has authorized or will authorize a DISTRICT representative to sign the Plan Approval page which is part of this document, prior to the STATE advertising for the work to be performed hereunder, approving the plans and specifications as prepared.
- 11. Under penalties of perjury, the DISTRICT certifies that its correct Federal Tax Identification number is 36-6009339 and it is doing business as a GOVERNMENTAL ENTITY, whose mailing address is:

Obligations of the STATE and the DISTRICT will cease immediately without penalty or further payment being required if, in any fiscal year, the Illinois General Assembly or Federal funding source fails to appropriate or otherwise make available funds for this contract.

This AGREEMENT and the covenants contained herein shall be null and void in the event that either (i) the PROPERTY ACQUISITION has not occurred within three year(s) subsequent to the execution of this Agreement or (ii) the contract covering the construction work contemplated herein is not awarded within the three years subsequent to execution of the agreement.

This Agreement shall be binding upon and to the benefit of the parties hereto, their successors and assigns.



**RECOMMENDATION:** Recommend approval of an Ordinance Setting Forth the Annual Appropriations for the Lake County Forest Preserve District for the Fiscal Year 2017/18, in the amount of \$103,669,000.

### STRATEGIC DIRECTIONS SUPPORTED: Organizational Sustainability

**<u>FINANCIAL DATA</u>**: The Fiscal Year 2017/18 Annual Appropriation Ordinance will be funded through the District tax levy and other sources authorized by law.

**BACKGROUND:** On May 1, 2017, the budget for Fiscal Year 2017/18 in the amount of \$73,591,970 will be presented to the Board for adoption. The proposed Appropriation Ordinance represents the second step in the process to accomplish the requirements of the Downstate Forest Preserve District Act 70 ILCS 805/13.3. The third step, The Tax Levy Ordinance, will be presented to the Board for approval prior to December 2017.

The Annual Appropriation Ordinance provides the authority to expend funds for salaries and benefits, commodities, contractuals, and capital outlays as may be required. The Ordinance proposes an appropriation of \$103,669,000 which includes:

WHEREAS, on May 9, 2017, the Lake County Forest Preserve District Board of Commissioners adopted the Annual Budget Ordinance for the Fiscal Year 2017/18; and

WHEREAS, the Downstate Forest Preserve District Act (70 ILCS 805/13.3), and the Lake County Forest Preserve District's "Rules of Order and Operational Procedures" adopted December 13, 2016, require that an Annual Appropriation Ordinance be adopted by the Lake County Forest Preserve District Board of Commissioners;

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT:** 

<u>Section 1</u>. <u>Recitals</u>. The recitals set forth above are incorporated as a part of this Ordinance by this reference.

<u>Section 2</u>. <u>Appropriations</u>. The following sums of money, or so much thereof as may be authorized by law, are or may be required to defray all necessary expenses and liabilities of the Lake County Forest Preserve District, and the same shall be, and they are hereby, appropriated for the objects and purposes hereinafter specified for the 2018 fiscal year beginning July 1, 2017, and ending June 30, 2018:

<u>Section 3.</u> <u>Legal Effect.</u> The appropriations made pursuant to Section 2 of this Ordinance shall be construed only as establishing the maximum total amounts authorized to be expended for the various objects and purposes stated in said Section and no such appropriation shall be construed to be, or to create, a commitment, agreement, obligation or liability of the Lake County Forest Preserve District nor shall any such appropriation authorize any expenditure of funds without, in each case, the approval of such expenditure by the Board of Commissioners of the Lake County Forest Preserve District or by such other person or entity authorized by applicable law.

Section 4. Unexpended Prior Appropriations. Pursuant to the Downstate Forest Preserve District Act (70 ILCS 805/13.2), any prior appropriation for the purpose of constructing, restoring, reconditioning, reconstructing, or acquiring improvements in the development of forests and lands of the District that has not yet been expended, shall not lapse and any sum of money levied, collected or received for that purpose shall be held for at least five years after its appropriation, to be used for the purpose for which it was appropriated. Any other sum of money appropriated, levied, collected or received for any object or purpose, but not yet expended, is hereby re-appropriated by this Ordinance for such object or purpose.

<u>Section 5.</u> <u>Severability.</u> If any appropriation made by, or any provision of, this Ordinance shall for any reason be held to be invalid or unconstitutional by any court or by any administrative body or official, such decision shall not affect the validity of any other appropriation made by, or any other provision of, this Ordinance.

<u>Section 6.</u> Filing with County Clerk. Pursuant to Section 18-50 of the Illinois Property Tax Code (35 ILCS 200/18-50), the District Treasurer is hereby directed to execute the certification attached to this Ordinance and the District Secretary is hereby directed to file a certified copy of this Ordinance with the County Clerk of Lake County, Illinois within 30 days after its passage and approval.

<u>Section 7.</u> <u>Effective Date; Publication.</u> This Ordinance shall be in full force and effect from and after its passage and approval by a concurrence of a majority of all the members constituting the Board of Commissioners of the Lake County Forest Preserve District and shall be published in pamphlet form within 10 days after its passage and approval.
