RECOMMENDATION: Recommend approval of a Resolution designating hours of operation for public access to the Bess Bower Dunn Museum of Lake County.

STRATEGIC DIRECTIONS SUPPORTED: Communication, Education and Outreach; Public Access and Connections

FINANCIAL DATA: No financial impact.

BACKGROUND: The infrastructure work to open the Bess Bower Dunn Museum of Lake County (Dunn Museum) is nearing completion. The move of the District's historic collections and the Lake County archives to Libertyville is underway and the exhibitions in the galleries are taking shape. In addition, staff is developing processes for the operation of the Dunn Museum.

Staff desires to maximize public access to both the galleries and research opportunities in the Lake County Archives created in the new location. Staff feels that this can best be accomplished by reallocating staff assignments and redistributing the hours of operation in order to provide a wide range of opportunity to visit.

The former gallery hours of operation were: 10 AM-4:30 PM Monday – Saturday and 1-4:30 PM on Sunday. The Lake County Archives had regular staff hours but members of the public were required to make an appointment to conduct research.

Recommended gallery hours for the Dunn Museum are: 10 AM - 5 PM Tuesday - Saturday and 12 PM - 5:00 PM Sunday. In addition, staff recommends that the Dunn Museum be open on the first and third Thursday evenings until 8 PM. District educators would offer programming each open Thursday evening. The Dunn Museum will be open to the public on all District holidays except: Thanksgiving, Christmas Eve, Christmas Day and New Year's Day.

Staff recommends that the Lake County Archives have regular hours available to the public, 12 PM - 4 PM Wednesday - Saturday or by appointment.

This schedule increases the hours available to the public to visit the resources of the Dunn Museum.
