**RECOMMENDATION:** Recommend approval of a Resolution approving a Temporary License Agreement with Wauconda Township (Township) allowing the District to perform restoration activities on a portion of Township property adjacent to Kettle Grove Forest Preserve.

#### **STRATEGIC DIRECTIONS SUPPORTED:** Conservation; Leadership

**FINANCIAL DATA:** There are no costs associated with the acquisition of the temporary license agreement. All costs associated with the restoration work have been approved as part of the FY 2017/2018 Budget, and will be charged to the Land Development Levy Fund, account 20104100-803200-61504. Funding for the project is coming from a private donation.

**BACKGROUND:** The District is involved in an extensive restoration project at Kettle Grove Forest Preserve (the "Preserve") that was initiated in 2015. As part of a more comprehensive analysis, staff is recommending that restoration activities including, but not limited to, invasive species control, native seed installation, controlled burning, and any other natural resource management actions deemed necessary be performed within the Preserve and within a portion of property owned by the Township adjacent to the Preserve. To complete the restoration and maintenance of the project area, the District requires a temporary license agreement, for a term of approximately five years, on approximately 1 acre of Township property.

The licensed 1-acre premises is fully surrounded by the north section of Kettle Grove Forest Preserve. Execution of this license agreement will provide the District legal access and use of the land owned by Township for restoration purposes.

As a condition of granting the temporary license, the District will be responsible for all costs associated with the restoration of the subject property.

# A RESOLUTION APPROVING A TEMPORARY LICENSE AGREEMENT WITH WAUCONDA TOWNSHIP FOR RESTORATION ADJACENT TO KETTLE GROVE FOREST PRESERVE

**WHEREAS**, the Planning Committee (the "Committee") of the Lake County Forest Preserve District (the "District") has determined that it is necessary and desirable to acquire a temporary license from Wauconda Township (the "Owner") to allow the District to perform restoration activities on the Owner's property, which is adjacent to Kettle Grove Forest Preserve, and which would be performed simultanteously with the District's restoration of Kettle Grove Forest Preserve (the "License"); and

**WHEREAS,** the District's Department of Planning and Land Preservation has negotiated a license agreement with the Owner pursuant to which the District would obtain the License from the Owner, in substantially the form attached hereto (the "License Agreement"); and

**WHEREAS**, it is in the best interests of the District to approve the License Agreement in substantially the form attached hereto;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois THAT:

<u>Section 1.</u> <u>Recitals.</u> The recitals set forth above are incorporated as part of this Resolution by this reference.

<u>Section 2.</u> <u>Approval of License Agreement</u>. The License Agreement is hereby approved. The President and Secretary of the District are hereby authorized and directed to execute and attest to, on behalf of the District, the License Agreement in substantially the form attached hereto.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.

# License Agreement between Lake County Forest Preserve District and Wauconda Township

This License Agreement (this "Agreement") is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_\_, 2017 (the "Effective Date") by and between Wauconda Township, a township organized and existing under the Township Code, 60 ILCS 1/1-1 et seq. (the "Township"), and the Lake County Forest Preserve District, a body politic and corporate, organized and existing under the Downstate Forest Preserve District Act, 70 ILCS 805/.001 et seq. (the "District"). In consideration of the recitals and agreements set forth in this Agreement, and pursuant to all applicable authority, including without limitation, the Illinois Constitution, the Intergovernmental Cooperation Act, 5 ILCS 220/1 et seq., the statutes and authorities identified above, and all other applicable authority, the District and the Township agree as follows:

#### Section 1. Recitals.

- A. The Township owns certain real property that is legally described on Exhibit A and generally depicted on Exhibit B as the "Township Parcel".
- **B.** The District owns certain real property adjacent to the Township Parcel that is commonly known as Kettle Grove Forest Preserve and that is generally depicted on Exhibit B as the "District Parcel".
- C. The District intends to perform certain ecological restoration work on the District Parcel, including the removal of invasive species, the planting of native species, and other related work (the "Kettle Grove Restoration Work").
- **D.** To increase the effectiveness of the Kettle Grove Restoration Work, the District also desires to perform similar ecological restoration work on the Township Parcel, including the following work (collectively, the "Township Restoration Work"):
  - during the winter of 2017-18, cutting down and removing invasive woody species (including but not limited to, Black Locust, Buckthorn, Asian Honeysuckle and Box Elder) by hand and mechanical methods,
  - (ii) disposing of cut invasive species via a combination of chipping, burning, and off-site removal,
  - (iii) treating stumps of cut species with appropriate herbicides,
  - (iv) during the spring of 2018, treating any re-sprouts from the cut invasive species stumps with additional herbicide applications as needed,

- (v) in the fall of 2018, planting a short-stature, native prairie mix, and
- (vi) in 2019 and beyond, performing additional invasive species control as needed, performing periodic controlled burns to assist in invasive species control and establishment of native species, and performing any additional management actions deemed necessary to improve and maintain a high quality natural area.
- E. The Township Parcel Restoration Work will increase the effectiveness of the Kettle Grove Restoration Work and improve the quality of the natural resources within the Township Parcel.
- F. The District and Township are currently negotiating an intergovernmental agreement pursuant to which, for valuable consideration, the Township would convey the Township Parcel to the District (an "IGA"). However, the parties desire to enter into this Agreement now, so that the District can complete the Township Restoration Work at the same time that the District performs the Kettle Grove Work, all for the benefit of both the District and the Township, while the parties continue to negotiate the IGA.
- <u>Section 2.</u> <u>Grant of License.</u> The Township hereby grants to the District, for the use of its officers, agents, employees, contractors or other designees, a license to enter upon and across the Township Parcel and to perform the Township Parcel (the "<u>License</u>").
- <u>Section 3.</u> The term of the License will commence on the Effective Date and end on the earlier of (i) the date upon which the District acquires the Township Parcel pursuant to an IGA and (ii) December 31, 2022.
- <u>Section 4.</u> <u>License Only; No Easement.</u> This Agreement creates contractual rights only and does not create an easement, a leasehold, or any other real property rights. The District shall not record this Agreement or notice of this Agreement.

#### Section 5. Insurance.

- A. <u>District's Insurance</u>. No later than the date upon which it commences any Township Parcel Restoration Work, and at all times while performing any Township Parcel Restoration Work, the District shall obtain and maintain appropriate and adequate general liability insurance coverage (i) that includes the Township as an additional insured with respect to any claim for death, personal injury, or property damage arising out of the District's alleged negligent acts or omissions related to the Township Parcel Restoration Work and (ii) in an amount not less than \$5 million. The Township hereby approves the certificate from the Park District Risk Management Agency attached as <u>Exhibit C</u> (the "<u>PDRMA Certificate</u>"), the self-insured risk pool of which the District is a member, as of the Effective Date, and agrees that, by submitting the PDRMA Certificate and maintaining the coverage identified in the PDRMA Certificate during the District's performance of the Township Parcel Restoration Work, the District will satisfy its obligations under the first sentence of this Section.
- B. <u>Contractor's Insurance</u>. The District shall cause each contractor performing any part of the Township Parcel Restoration Work to obtain and maintain while such contractor is performing any Township Parcel Restoration Work appropriate and adequate general liability insurance coverage that includes the Township as an additional insured with respect to any claim

for death, personal injury, or property damage arising out of the contractor's alleged negligent acts or omissions related to the Township Parcel Restoration Work.

C. <u>Indemnification</u>. The District shall hold harmless, indemnify, and defend the Township and its officers, agents, employees, and attorneys against any and all losses, expenses, claims, costs, causes of action, and damages, including litigation costs and attorneys' fees, resulting or alleged to result from death, personal injury, or property damage, arising from the negligent acts or omissions of the District, up to and subject to the additional insured coverage provided pursuant to Section 4.A. In addition, in each of its contracts with a contractor performing any part of the Work, the District shall require such contractor to hold harmless, indemnify, and defend the Township and its officers, agents, employees, and attorneys against any and all losses, expenses, claims, costs, causes of action, and damages, including litigation costs and attorneys' fees, resulting or alleged to result from death, personal injury, or property damage, arising from the negligent acts or omissions of the contractor, up to and subject to the additional insured coverage provided pursuant to Section 4.B.

#### Legal Description of the Township Parcel

THAT PART OF THE LAND LYING NEAR THE NORTH LINE OF THE NORTHEAST 1/4 OF SECTION 1, TOWNSHIP 44 NORTH, RANGE 9 EAST ACCORDING TO UNITED STATES SURVEY ONE ACRE OF LAND BOUNDARIES AS FOLLOWS:
