**IN 1963, THE LAKE COUNTY FOREST PRESERVES ACQUIRED VAN PATTEN WOODS—the first step in a long-term vision to protect land all along the Des Plaines River. On October 23, 2015, we realized this vision when we completed the final 1,500 feet of the 31.4-mile Des Plaines River Trail and Greenway. Today, the people of Lake County can enjoy an uninterrupted recreational trail that runs from Wisconsin to Cook County.**

### GREEN INFRASTRUCTURE VISION FOR LAKE COUNTY

### RAMSAR WETLAND OF INTERNATIONAL IMPORTANCE



Spring Bluff Forest Preserve is part of a 4,000-acre bi-state wetland complex, recognized in 2015 as a RAMSAR Wetland of International Importance. The state-endangered Blanding's turtle can now be found on this globally rare landscape, thanks to a multi-partner restoration effort led by the Forest Preserves.
