RECOMMENDATION: Recommend approval of a Resolution awarding a Contract for the Lake Plain Invasive Plant Strike Team Project at Spring Bluff Forest Preserve to Native Restoration Services, Inc., Lake Bluff, Illinois in the Contract Price of \$205,159,57.

STRATEGIC DIRECTIONS SUPPORTED: Conservation; Leadership

FINANCIAL DATA: This project was approved as part of an amended FY 2017/2018 Capital Improvement Plan in the amount of \$1,000,000.00. This portion of the project was estimated at \$205,159.60. The actual cost of \$205,159.57 will be charged to the Natural Resources Grant Fund, (69642400-803200-56050). The overall Lake Plain restoration project was awarded a \$1,000,000.00 grant from the National Fish and Wildlife Foundation.

BACKGROUND: With funding provided by the US Fish and Wildlife Service through the National Fish and Wildlife Foundation's Sustain Our Great Lakes Stewardship Program, the proposed contract with Native Restoration Services, Inc. would provide Lake Michigan Lake Plain landowners a means to effectively and efficiently control a suite of 18 priority invasive plant species within 6,000 acres of high quality coastal natural areas in Kenosha County, Wisconsin and Lake County, Illinois. Working on an hourly basis, the Contractor shall provide invasive plant management control for three years, with the majority of the work occurring during the growing seasons.

The coastal natural areas located between Kenosha, Wisconsin and Waukegan, Illinois support the best remaining and most diverse ecosystems along the southwestern shore of Lake Michigan. Partners involved in this project include the Lake County Forest Preserve District, Wisconsin Department of Natural Resources, The Nature Conservancy, University of Wisconsin Parkside, Chiwaukee Prairie Preservation Fund, Inc., Village of Pleasant Prairie, Wisconsin, Village of Winthrop Harbor, Illinois, Illinois Department of Natural Resources, Zion Park District, and Zion Solutions LLC/Exelon. The District will lead the administration of the Lake Plain Strike Team contract with daily implementation of the project by partners and the District.

The project was advertised on October 20, 2017 and 5 bids were received. A summary of the bids received is listed below:
