SUBJECT:	Renewals of Contracts for the Purchase of Motor Fuel

<u>RECOMMENDATION</u>: Recommend approval of a Resolution approving one-year renewal of contracts with Petroleum Traders Corporation, Fort Wayne, Indiana, and Avalon Petroleum Co., Antioch, Illinois, for the purchase of motor fuel (gasoline and diesel) for use by the District.

BACKGROUND: The District has entered into contracts with Petroleum Traders Corp. and Avalon Petroleum Co. pursuant to which the District may purchase motor fuel for its own use and for use by the Lake County Sheriff's Office and the Lake County Division of Transportation. All expenses incurred by the District for fuel used by Sheriff's Office and County DOT are reimbursed to the District by the County of Lake. The initial terms of the contracts expired on November 20, 2013, and each contract allowed for two one-year renewal periods. In 2013, the District exercised one-year renewals of each contract. Those renewals expire November 20, 2014. Staff recommends that the District exercise an additional one-year renewal period for each contract.

<u>REASON FOR RECOMMENDATION:</u> Committee recommendation and Board approval are required in accordance with District Policy.

REVIEW BY OTHERS: Director of Finance and Purchasing Manager

FINANCIAL DATA: Motor fuel is ordered on an as-needed basis. A total of \$562,000.00 is budgeted annually for motor fuel and oil products as part of the approved 2014/15 General Corporate Budget (\$345,000.00 in Account Number 15533800-611000), Development Levy Budget (\$100,000.00 in Account Number 20533800-611000) and the Golf Enterprise Budget (\$117,000.00 in various accounts). All expenses incurred by the District for the use of fuel by the Lake County Sheriff's Office and the Lake County Division of Transportation are reimbursed to the District by the County of Lake.
