RECOMMENDATION: Recommend approval of a Resolution awarding a Contract to Morton Salt, Inc., for Bulk Road Salt in an amount not to exceed \$34,034.00 for a one-year period commencing July 15, 2018.

STRATEGIC DIRECTIONS SUPPORTED: Organizational Sustainability, Public Access and Connections

FINANCIAL DATA: Road salt is ordered on an as-needed basis. The not-to-exceed contract amount of \$34,034.00 is based on the purchase and delivery of 550 tons at a unit price of \$61.88 per ton. The actual amount spent will be based on actual usage and charged to account 15523800-641100 for Grounds Maintenance supplies. The FY2018/19 Budget for Grounds Maintenance supplies is \$162,500.00.

BACKGROUND: Road salt is purchased annually and is used for de-icing District roads and parking lots during the winter months throughout the District. The not-to-exceed price of the contract is based upon a usage of 550 tons and is eligible for pricing under Lake County Material Contract #19-00000-05-GM at a price of \$61.88 per ton. That contract was let for bidding and awarded by Lake County in 2018. After it solicited competitive bids, Morton Salt, Inc. was determined to be the lowest responsible bidder. The County contract authorizes other units of local government to enter into their own contracts with Morton Salt, Inc. accordingly. The pricing of the District contract is the same as the pricing in the County contract. As provided in the County contract, the contract may be renewed by the District for one additional year for the winter of 2019-2020, subject to Morton's right to increase the unit price up to 5%.

WHEREAS, the Lake County Forest Preserve District (the "District") desires to purchase road salt for the 2018-2019 season (the "Material); and

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act, 30 ILCS 525/1, et seq., any governmental unit may purchase personal property, supplies, and services jointly with one or more other governmental units if one of the governmental units has publicly advertised for, and received, competitive, sealed bids or proposals and has awarded a contract for such personal property, supplies, and services to the lowest responsible bidder or highest ranking proposer, all in accordance with such Act; and

WHEREAS, Lake County has publicly advertised for, and received, competitive sealed bids for the Material, including a bid by Morton Salt, Inc., in the amount of \$61.88 per ton; and

WHEREAS, Lake County has awarded a contract for the Material to Morton Salt, Inc., as the lowest responsible bidder for the Material Contract #19-00000-05-GM; and

WHEREAS, it is in the District's best interest to award a contract for the Material to Morton Salt, Inc. (the "Contract"); and

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:

Section 1: Recitals. The recitals set forth above are incorporated as part of this Resolution by this reference.

Section 2: Award of Contract. The bid submitted by Morton Salt, Inc., in the amount of \$61.88 per ton (the "Contract Price") is hereby accepted and a Contract for the Material is hereby awarded to Morton Salt, Inc.; however, the total price paid pursuant to the Contract shall not exceed \$34,034.00.

<u>Section 3:</u> <u>Execution of Contract; Future Extension.</u> The Executive Director and Secretary of the District are hereby authorized to execute and attest to the Extension on behalf of the District. The Executive Director is hereby authorized to approve the Future Extension on behalf of the District.

<u>Section 4:</u> <u>Payments.</u> The District Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.
