AN ORDINANCE ADOPTING RULES OF ORDER AND OPERATIONAL PROCEDURES

WHEREAS, the Lake County Forest Preserve District (the "District") is authorized by the Downstate Forest Preserve District Act to adopt all necessary ordinances, rules, and regulations for the management of its property and the conduct of its business, 70 ILCS 805/8, and pursuant to such authority the District has adopted Rules of Order and Operational Procedures regarding District Board meetings, committees, finances, property, and other matters; and

WHEREAS, on December 1, 2014, the President of the Lake County Forest Preserve District appointed a Rules Committee for the purpose of reviewing and recommending modifications to the District's Rule of Order and Operational Procedures; and

WHEREAS, the Rules Committee met on December 4, 2014 to review the Rules of Order and Operational Procedures for December 2014 through December 2016 and recommends adoption of this Ordinance, including the Rules of Order and Operational Procedure attached hereto;

NOW, THEREFORE, BE IT ORDAINED, by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, THAT:

Section 1: <u>Recitals</u>. The recitals set forth above are incorporated as a part of this Ordinance by this reference.

Section 2: <u>Approval of Rules of Order and Operational Procedures</u>. The Rules of Order and Operational Procedures, attached hereto and incorporated as Exhibit "A", are hereby approved.

Section 3: Effective Date. This Ordinance shall be effective upon its passage and approval in the manner provided by law.
