RECOMMENDATION: Recommend approval of a Resolution awarding a Contract for the 2019 Reforestation Watering at Multiple Forest Preserves (Grassy Lake, Lakewood, Lyons Woods, Ray Lake, and Van Patten Woods) to McGinty Bros., Inc., Long Grove, Illinois, in the Contract Price of \$36,780.00.

STRATEGIC DIRECTION SUPPORTED: Conservation

FINANCIAL DATA: This project is a portion of the District-wide Reforestation project and was approved as part of the adopted FY 2018/2019 Capital Improvement Plan in the amount of \$150,000.00. This portion of the project was estimated at \$35,000.00. The actual cost of \$36,780.00 will be charged to the District-wide Reforestation account (20104100-803200-60008).

BACKGROUND: This project will take place at Grassy Lake, Lakewood, Lyons Woods, Ray Lake, and Van Patten Woods Forest Preserves and will provide supplemental watering treatments to 2,793 newly planted trees and shrubs installed in the fall of 2018.

The project was advertised on November 26, 2018 and three bids were received. A summary of the bids received is listed below:

The bid submitted by Alvarez, Inc., which did not contain the required commitment letters regarding insurance coverage and bonding, is not a responsive bid for the Work. Staff recommends that McGinty Bros., Inc. be awarded the contract as the lowest responsible bidder. Work is anticipated to begin May 1, 2019 and be completed by October 31, 2019.

(the "Contract); and

WHEREAS, the Board of Commissioners hereby finds that McGinty Bros., Inc., is the lowest responsible bidder for the Work, as set forth in the previous clause;

<u>Section 4:</u> <u>Execution of Contract.</u> The Executive Director of the District is hereby authorized and directed to execute the Contract for the Work in the amount of the Contract Price.

<u>Section 5:</u> <u>Payments</u>. The Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.

<u>Section 6:</u> <u>Effective Date</u>. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
