RECOMMENDATION: Recommend approval of a Resolution Awarding a Contract for the Maintenance Shop Remodel at Van Patten Woods Forest Preserve to Stuckey Construction Company, Inc., Waukegan, Illinois, in the Contract Price of \$149,000.00.

STRATEGIC DIRECTION SUPPORTED: Organizational Sustainability

FINANCIAL DATA: The remodeling of the Van Patten Woods Forest Preserve Maintenance Shop was funded as part of the Board approved FY2018-2019 CIP Budget for Facility and Infrastructure Improvements. The project cost of \$149,000.00 is included in the \$1,300,693.00 budgeted for Facility and Infrastructure improvements and will be charged to account number 20104100-803200-60022.

Nine bids were received. After reviewing the bids and relevant information, including references, staff recommends that Stuckey Construction Company, Inc. be awarded the contract as the lowest responsible bidder for the project.

BACKGROUND: The remodeling of the Van Patten Woods Forest Preserve Maintenance Shop will address repairs, upgrades and improvements to the facility, which is over 30 years old and has begun to show signs of failure.

Section 5: Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
