<u>RECOMMENDATION</u>: Recommend approval of a Resolution approving an amendment to the 2019 Legislative Program for the Lake County Forest Preserve District to amend the Downstate Forest Preserve District Act to change the threshold requirement for competitive sealed bidding.

STRATEGIC DIRECTIONS SUPPORTED: Organizational Sustainability; Leadership

FINANCIAL DATA: There is no immediate financial impact. If the amendment is adopted and the District is successful in then amending the Downstate Forest Preserve Act there will be a significant staff time savings in purchasing equipment and awarding small contracts.

<u>BACKGROUND</u>: In November 2018 the Board of Commissioners approved a resolution approving the District's 2019 Legislative Program, which included the language:

Establish responsible and efficient purchasing/contracting authority, including the ability to use Design-Build contracts.

Municipalities, park districts, and counties already have such design-build authority. Staff is recommending that this language be amended to read:

Establish responsible and efficient purchasing/contracting authority, including the ability to use Design-Build contracts as well as increasing the dollar level that triggers the statutory requirement for a sealed competitive bidding process to up to \$50,000.

In discussing this issue with other Forest Preserve Districts and the District's Finance Department staff, it became apparent that, if we are proposing to amend the section of the Act governing the District's purchasing authority, it may be advantageous to also amend the statutory dollar level that triggers the formal bidding process. That level is currently \$25,000. The level for the county is \$30,000.

Most contracts and purchases under \$50,000 are relatively simple transactions. Going out for formal bids is a time-consuming and staff-intensive process. In most cases, the District's professional purchasing staff would be able to informally solicit and analyze quotes or proposals for this level of project in a matter of days, rather than the weeks it takes to complete the formal competitive bidding process, which requires publishing notice in a newspaper, waiting for sealed bids to be submitted, and analyzing all bids to ensure they are conforming. Staff believes that, for contracts between \$25,000 and

\$50,000 in value, they can still get favorable financial terms for the District, even if utilizing a less formal quote or proposal process (as compared to an advertised, sealed competitive bid process).

This issue was presented to, and discussed by, the Legislative Committee on March 4 and the Finance Committee on March 7. The Committees gave Policy Direction to staff to prepare a resolution amending the Legislative Program to increase the competitive bidding threshold to \$50,000.

(the "Program Amendment");
