<u>RECOMMENDATION</u>: Approve Change Order No. 3 to the Contract with ADP, LLC, to convert specific historic human resources information from the District's prior legacy system to the web-based platform, History Viewer, in an amount not to exceed \$9,950.00.

STRATEGIC DIRECTION SUPPORTED: Organizational Sustainability

<u>FINANCIAL DATA</u>: The District budgeted \$100,000.00 in account 19214000 805200 Computer Software. This change order brings the total contract price to \$86,426.90, still within the budgeted amount.

BACKGROUND: On June 21, 2018, the District entered into a contract with ADP, LLC, for Outsourced Payroll & Human Resource Information Services. During the initial data conversion, it was unknown if the District would be able to extract usable historical data from the County's legacy system, BOSS. After working with a consultant, the District has been able to extract five years' worth of historical data including rate of pay, position title, status and training. At this time, the District wishes to amend the Contract with ADP, LLC, to allow the import of historical data into an ADP database, History Viewer.

Written Determination Regarding Change Order No. 3 to Contract between Lake County Forest Preserve District and ADP, LLC

The Finance Committee of the Lake County Forest Preserve District (the "District") has approved Change Order No. 3 (the "Change Order") to the Contract between the District and ADP, LLC for the conversion of specific data from the legacy Human Resource System to ADP's *History Viewer* (the "Contract"), and further makes the following written determination:

- a. The circumstances necessitating the Change Order were not reasonably foreseeable at the time the Contract was signed;
- b. the Change Order is germane to the original Contract, as signed; and
- c. the Change Order is in the best interest of the District.

This Written Determination and the Change Order shall be preserved in the permanent District file for the Contract. This Written Determination shall constitute the Written Determination required by Section 33E-9 of the Illinois Criminal Code, 720 ILCS 5/33E-9.
