**RECOMMENDATION:** Recommend approval of a Resolution awarding a two-year contract for printing and distribution of eight issues of Horizons to Dreamworks Graphic Communications, LLC, of Glenview, Illinois, in the Contract Price of \$136,253.82.

**STRATEGIC DIRECTIONS SUPPORTED:** Communications, Education and Outreach; Public Access and Connections; Leadership; Conservation; Organizational Sustainability.

<u>FINANCIAL DATA:</u> Funding for the eight-issue contract is included in the Public Affairs and Development Department budget (11314000-702100-42001). Funding for four issues (spring, summer, fall, winter 2020 issues) will be included in the Fiscal Year 2020 Budget in the amount of \$68,126.91. Funding for the remaining four issues of the contract (spring, summer, fall, winter 2021) will be included in the Fiscal Year 2021 Budget Proposal in the amount of \$68,126.91.

**BACKGROUND:** As our lead print communications tool, Horizons focuses on educating Lake County residents about the District's commitment to open space preservation, trails, wildlife habitat, nature and history education, facilities and amenities, accomplishments, fundraising efforts, and responsible use of tax dollars and referenda funds. Engaging editorial along with high-impact, full-color photography and design creates a tangible presence, and leaves the public with a positive perception of their Lake County Forest Preserves. Horizons is regularly used as an introduction and leave-behind piece for constituents and potential donors. It also serves as a catalyst and engagement piece for Preservation Foundation giving initiatives.

The giving envelope included in each issue of Horizons prompted \$31,924 in revenue for the Preservation Foundation from the spring 2018 issue through the fall 2019 issue.

Mailed to 32,300 subscribers each quarter, Horizons reaches the single largest audience of District supporters. By request, approximately 6,200 additional copies are distributed each quarter to forest preserve facilities, colleges, medical offices, businesses, realtors, municipalities, park districts, libraries, hotels, Visit Lake County, and various Chambers of Commerce.

The content in each issue helps drive readers to the District's website and social media outlets such as Facebook, Twitter, Instagram, and Flickr, where they can find additional resources and become further engaged with the mission.

Feature articles cover a variety of reader-requested topics on nature and wildlife, preserve and facility amenities, and the history of Lake County.

The Horizons calendar pages promote all summer camps, environmental education, history, and Dunn Museum programs, bringing the District a total combined revenue of \$63,706 in 2018.

Preserve news pages are used to promote dog permits, picnic shelter rentals, golf gift cards, Independence Grove beach passes, summer concerts, marina rentals, Fox River boat slips, and Dunn Museum exhibitions, which all bring revenues to the District.

Bids were solicited for printing and distributing eight issues of Horizons (38,000 copies per issue; 304,000 total copies) beginning with the spring 2020 issue and ending after the printing of the winter 2021 issue. Bids were advertised in the *News Sun*. Specifications were reviewed by 18 vendors. Three vendors submitted bids. An optional pre-bid meeting was held on September 4 and attended by one vendor.

Staff recommends that Dreamworks Graphic Communications, LLC, Glenview, Illinois, be determined to be the lowest responsible bidder. Based on its review, staff has concluded that this bidder meets all of the project specifications and has provided evidence of its ability to successfully fulfill this contract. This bidder is the current printing contractor for Horizons.

The Dreamworks Graphic Communications, LLC, eight-issue contract bid is itemized as follows:
