FINANCIAL DATA: This contract was approved on August 14, 2018 in the amount of \$30,000.00. Change Order No. 1 to the contract was processed on June 27, 2019, which increased the contract amount by \$6,000.00 to \$36,000.00. Change Order No. 2 will increase the contract amount by \$4,146.67 to a total Contract Price of \$40,146.67, which will cover the total cost of all purchases made during the contract term that ended on August 1, 2019. The cost will be charged to the District's Central Supply, account 100000000-169900.

BACKGROUND: This contract is for the purchase of janitorial and sanitation supplies, which are used District-wide. The term of the contract is from August 14, 2018 August 1, 2019. This change order includes an additional \$4,146.67 to cover the actual total cost of supplies purchased during the contract term.

<u>Section 4: Reapproval of the Contract.</u> The Contract is hereby reapproved, except to the extent that it has been changed by or conflicts with the Change Order or this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
