RECOMMENDATION: Recommend approval of a Resolution approving a one-year renewal of a Contract for Janitorial Services to Total Facility Maintenance, Inc., Wood Dale, Illinois in the amount of \$53,935.00.

STRATEGIC DIRECTION SUPPORTED: Organizational Sustainability

FINANCIAL DATA: Funding for janitorial services at various District facilities was approved in the Fiscal Year 2020 budget in the total amount of \$68,180.00, allocated amongst several accounts. The cost of the janitorial services is charged to the various accounts based on the location of the facility served (General Offices, Dunn Museum, Operations and Public Safety Facility, Ryerson buildings or Stevenson service building).

BACKGROUND: On October 9, 2018, the District entered into a contract with Total Facility Maintenance, Inc., for a one-year period. In the contract, the District reserved the right to renew the contract for up to two additional one-year periods. If approved, this renewal will be the first extension and will cover the period of January 1, 2020, through December 31, 2020.
