#### AN ORDINANCE AMENDING PERSONNEL POLICY 4.1 – PAID HOLIDAYS

**WHEREAS,** on August 15, 1980, the Lake County Forest Preserve District (the "District") passed and approved certain Personnel Policies ("Policies") and Procedures, which have been amended from time to time; and

**WHEREAS,** it is in the best interest of the District to amend Policy 4.1 with respect to paid holidays; and

**WHEREAS**, such amendment to Policy 4.1 shall be in the form of Exhibit A attached to this Ordinance and incorporated herein by this reference (the "Amendment");

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:

<u>Section 1</u>: <u>Recitals</u>. The recitals set forth above are incorporated as a part of this Ordinance by this reference.

**Section 2: Approval of Amendment.** The Amendment is hereby approved. The Executive Director is hereby authorized and directed to amend the Policy in accordance with the Amendment.

Section 3: Effective Date. This Ordinance shall be in full force and effect on January 14, 2020.

The following days are authorized holidays granted by the District:

New Year's Day Martin Luther King<u>'s Birthday Jr. Day</u> Lincoln's Birthday Good Friday Memorial Day Independence Day Labor Day Columbus Day Veteran's Day Thanksgiving Day Day after Thanksgiving Christmas Eve Christmas Day

New Year's Day, <u>Martin Luther King Jr. Day</u>, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Day after Thanksgiving, Christmas Eve and Christmas Day are fixed holidays. All other holidays are floating holidays. On the floating holidays, departments are required to remain open.
