RECOMMENDATION: Recommend approval of an Ordinance amending the Fiscal Year 2020 Budget to reflect carryovers for projects budgeted but not completed in Fiscal Year 2018-2019.

STRATEGIC DIRECTION SUPPORTED: Organizational Sustainability

FINANCIAL DATA: The items were approved projects from FY2018-2019 and the accounts and amounts are detailed on the attached report.

BACKGROUND: The list of accounts and dollar amounts attached to the attached resolution identifies projects that were budgeted for and started in FY2018-2019, but that were not completed by December 31, 2019. Under generally accepted accounting principles (GAAP), such projects should not be expensed in the year in which purchase orders were issued; instead, the next year's fiscal budget should be modified to include in that budget the unexpended balance of the budgeted item that is expected to be expended in that next fiscal year ("carryover expenses").

Each year, the District adopts an ordinance to amend the current year budget to add the carryover expenses from the prior year. Accordingly, this ordinance amends the FY2020 budget to add the carryover expenses from FY 2018-2019 in the total amount of \$15,718,435.47.

Every fiscal year, the District uses language in its appropriations ordinance stating that sums of money appropriated for development of District lands that have not yet been expended, shall not lapse and money received for that purpose shall be held at least five years after its appropriation, to be used for the purpose for which it was appropriated. Therefore, there is no legal reason to amend the appropriations ordinance to re-approve such expenses.

AN ORDINANCE AMENDING THE FISCAL YEAR 2020 BUDGET FOR EXPENDITURES BUDGETED BUT NOT COMPLETED IN FISCAL YEAR 2018-2019

WHEREAS, the Lake County Forest Preserve District (the "District") has previously approved an Annual Budget for Fiscal Year 2018/19 (the "2019 Budget") and an Annual Budget for Fiscal Year 2020 (the "2020 Budget"); and

WHEREAS, in Exhibit A attached hereto, the projects and expenditures listed under the column entitled "Account Description" (the "Carry Over Projects") were budgeted in the 2019 Budget and were started but not completed during Fiscal Year 2018-2019; and

WHEREAS, specifically, for each Carry Over Project there remains an amount that (i) was budgeted but unexpended from the 2019 Budget, (ii) is anticipated to be expended in Fiscal Year 2020, and (iii) is equal to the amount corresponding to such Carry Over Project under the column entitled "Carry Over " in Exhibit A (the "Carry Over Expenses"); and

WHEREAS, is in the best interest of the District to amend the 2020 Budget to allow the District to expend the Carry Over Expenses to perform the Carry Over Projects;

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:

<u>Section 1</u>: <u>Recitals</u>. The recitals set forth above are incorporated as part of this Ordinance by this reference.

<u>Section 2</u>: <u>Approval of Listed Projects</u>. The Carry Over Projects and Carry Over Expenses are hereby reapproved as part of the 2020 Budget.

<u>Section 3</u>: <u>Amendment of the 2020 Budget</u>. The 2020 Budget is hereby amended to include the Carry Over Projects and the Carry Over Expenses. The Director of Finance is hereby authorized to take any further action necessary to effectuate such amendment.

<u>Section 4</u>: <u>Effective Date</u>. This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
