SUBJECT: Changes to the 5-Year Capital Improvement Plan (CIP)

RECOMMENDATION: Review the proposed changes to the 5-Year CIP, and forward for other Committees to review as part of the FY 2015-2016 budget process.

BACKGROUND: As part of the annual budget process, the 5-year CIP and the list of potential unfunded capital improvement projects are reviewed and amended as recommended by the Planning and Restoration Committee, and with input from other Standing Committees. The final version of the updated 5-year CIP is approved by the Board when the budget is adopted.

The recommended adjustments to the CIP fall into two categories: 1) adjustments to existing funded projects on the CIP, and 2) new projects recommended to be funded or added to the CIP.

Adjustments to existing funded projects on the CIP:

- 1) Ethel's Woods- North Mill Creek Restoration (\$500,000). The District was notified in June 2014 that this project was awarded a Section 319 grant from the Illinois Environmental Protection Agency to support the restoration of Rasmussen Lake and nearly one mile of North Mill Creek. Phase I construction began in fall 2014 with Phase II to follow in FY2016-17. The project budget can be reduced due to this funding assistance.
- 2) <u>Ethel's Woods Public Access \$100,000.</u> As part of the requirements of the land acquisition OLT grant received for the purchase of Ethel's Woods Forest Preserve, public access improvements are needed including a new entrance, parking lot, restroom, one mile of trail and two scenic overlooks. Further refinement of the cost estimate has identified that additional funding is needed for the construction associated with this project.
- 3) <u>Everett Road Trail Connection \$300,000.</u> As final engineering progresses for the proposed trail connection, a detailed cost estimate has been prepared further identifying that additional funding is needed for the construction associated with this project. Construction is anticipated to begin in spring 2016.
- 4) General Offices Build Out/Miscellaneous Infrastructure \$3,750,000. The District was notified in June 2014 that this project was awarded funding assistance through the Illinois Department of Natural Resources Public Museum Capital Grant Program in the amount of \$750,000. After the completion of more detailed design and engineering plans, a more accurate cost estimate has been developed identifying that additional funding is needed to complete the relocation of the entire Lake County Discovery Museum archives and collections to the General Offices. In addition to the Grant funding and the \$700,000.00 that is presently budgeted, it is recommended that the remainder of the required

- additional funds be allocated in the following manner: \$659,928.00 from the General Fund, \$340,072.00 from the Capital Facilities Improvement Fund and \$1,300,000.00 from the Endowment Fund. Construction is anticipated to begin in June 2015.
- 5) <u>Gilmer Road Crossing \$60,000.</u> This project is part of the Fort Hill Trail extension providing an important connection linking together Lakewood and Ray Lake Forest Preserves and was partially funded through the Illinois Transportation Enhancement Program (ITEP) administered through IDOT. The project was complete and opened to the public in June 2012. As part of IDOT's project closeout procedures, a more accurate cost estimate has been developed identifying that additional funding is needed to fulfill the District's local share requirement.
- 6) <u>Grassy Lake Improvements (Hurd Property) \$500,000.</u> Due to higher than expected bid results, approximately \$330,000 of restoration work was removed from the original project scope. In order to complete the original project scope and Phase II restoration of the site, additional funding is needed. Phase I public access improvements are scheduled to open in fall 2015 and it is anticipated that Phase II restoration will begin in winter 2015-16.
- 7) <u>Hastings Lake (\$400,000).</u> This project will be completed in May 2014 and the project budget can be reduced due to the funding received from the OSLAD grant.
- 8) <u>Lyons Woods to Waukegan Savanna Trail Connection \$950,000.</u> The District is partnering with the City of Waukegan, Waukegan Park District and Waukegan Township Highway Department on this project which has been identified as a strong candidate for federal funding through either the CMAQ or TAP programs administered through IDOT. Additional funding is needed for Phase II engineering and for the local share of the construction costs. CMAQ applications are due on March 28, 2015.
- 9) <u>Millennium Trail Wilson Road Crossing \$525,000.</u> The District was notified in January 2014 that this project had been approved for funding assistance through the Transportation Alternatives Program (TAP) administered through IDOT. Consequently, as part of the approved CIP adjustments completed last year, the District removed \$1,914,766 from the project budget for this fiscal year. Due to higher than expected bid costs, additional funding is needed to complete the construction of the underpass and trail connection. The project is currently under construction and is scheduled for completion in late 2015.
- Millennium Trail Rollins Road Crossing (\$154,492). The District received federal funding assistance for this project through the Illinois Transportation Enhancement Program (ITEP) administered by IDOT. The project was completed and opened to the public in the fall 2014. As part of IDOT's closeout procedures a more accurate cost estimate has been developed identifying the final local share requirement. The project budget can be reduced due to excellent bid prices and project management.
- Millennium Trail Grand Avenue Crossing \$75,000. The District received federal funding assistance for this project through the ITEP program administered by IDOT. The project was completed and opened to the public in August 2013. As part of IDOT's project closeout procedures, a more accurate cost estimate has been developed identifying that additional funding is needed to fulfill the District's local share requirement.
- Millennium Trail Route 45 Tunnel (Ethel's Woods) \$50,000. This project has been identified as a good candidate for federal funding assistance through either the CMAQ or TAP programs administered through IDOT. In anticipation of receiving funding assistance and the possibility of combining this project with the Ethel's Woods Public Access project, additional funding is needed for the local share of the construction costs. It is anticipated that the District will apply for funding assistance in the 2016 grant cycle.
- Millennium Trail Van Patten Woods Connection \$275,000. The District is partnering with the Lake County Division of Transportation (LCDOT) to extend the Millennium Trail along Russell Road from old Route 41 east to the Van Patten Woods entrance and the Des Plaines River Trail. After more detailed engineering and refinement of the plans as required by LCDOT, it has been determined that additional funding is needed for this project.
- Nippersink Trail Connection (\$83,516). Phase I of this project was completed in July 2013 and the budget can be reduced due to excellent bid prices and construction management. The District is partnering with the LCDOT on Phase II of the project which includes a 0.75-mile trail connection from the existing preserve trails to Cedar Lake Road. Implementation of Phase II is being coordinated with

- LCDOT's planned Cedar Lake Road improvements which are currently scheduled for FY2017-18.
- Spring Bluff Wildlife Observation Area (\$263,700). The District was notified January 4, 2015 that this project was approved for funding assistance as part of the State's Open Space Lands Acquisition and Development (OSLAD) grant program. The project budget can be reduced due to this funding assistance.
- Mright Woods/MacArthur Woods Dam Removal \$50,000. Due to complications during construction, the existing contract to remove two low-head dams on the Des Plaines River was terminated. After revising the construction plans, an updated cost estimate has been prepared identifying that additional funding is needed accommodate the additional scope of work identified during the initial construction.

Projects recommended to be funded or added to the CIP:

- 1) <u>Grant Woods Restoration \$600,000.</u> In 2014, the Preservation Foundation received a private donation to fund restoration work at Grant Woods Forest Preserve. The work will occur across 665 acres and will focus on wetland, stream and oak woodland restoration within the Gavin Bog and Fen Nature Preserve area. Estimated annual operating cost is \$6,000.00.
- 2) <u>Heron Creek IL. Route 22 Trail Connection \$20,000.</u> The District has been working with the Illinois Department of Transportation (IDOT) regarding their planned improvements to Route 22 which includes the construction of a shared-use path on the south side of Route 22 that will provide an important connection linking together Egret Marsh and Heron Creek Forest Preserves. As part of IDOT's improvements, a 350' section of trail will be constructed connecting the proposed shared-use path to the existing trail at Heron Creek. The District will be required to cover the local share cost for the engineering and construction of this short trail section. Construction is anticipated to begin in FY2016-17. Estimated annual operating cost is \$600.00.
- Lakewood Tree Planting & Restoration \$500,000. As part of the Lake County Division of Transportation's (LCDOT) Fairfield Road and Route 176 intersection improvement project, LCDOT has provided funding to the District in the amount of \$500,000 as mitigation for the tree impacts associated with the project. As the District gets closer to implementing the restoration and tree planting near the intersection, it is important that we establish a separate line item in the CIP. The restoration and tree planting is scheduled to occur in FY2015-16 and FY2016-17. Minimal impacts to the annual operating costs.
- 4) <u>Millennium Trail McDonald Woods to Route 45 \$185,000.</u> As part of the planned Millennium Trail extension connecting McDonald Woods, Raven Glen and Ethel's Woods Forest Preserves, the District is partnering with the Illinois Department of Transportation (IDOT) to incorporate a shared-use path within the planned Millburn Bypass and Illinois Route 45 improvements. Funding is needed for the engineering and construction of a 0.20-mile trail connection from the existing McDonald Woods preserve trails east to Route 45. Construction is anticipated to begin in FY2017-18. Estimated annual operating cost is \$1,800.00.
- Singing Hills/Kettle Grove Restoration \$500,000. In 2013 and 2014, the Preservation Foundation received two private donations totaling \$500,000 to fund a high priority habitat restoration project(s) throughout the District. Staff recommends directing these funds to support restoration at Singing Hills and Kettle Grove Forest Preserves. The work at Singing Hills will occur across 700 acres and will focus on restoration of a portion of Monahan Lake and a Calcareous Fen. The work at Kettle Grove will occur across 248 acres and will focus on restoration of Sargent Marsh and the surrounding oak woodlands. Estimated annual operating cost is \$9,000.00.
