**RECOMMENDATION:** Recommend approval of a Resolution awarding a Contract for Advance Tree Clearing and Harvesting at Lakewood Forest Preserve to Homer Tree Service, Inc., Lockport, Illinois in the Contract Price of \$40,250.00.

**STRATEGIC DIRECTIONS SUPPORTED:** Public Access and Connections; Conservation.

<u>FINANCIAL DATA</u>: This work is part of a project approved in the adopted FY2020 Capital Improvement Plan in the amount of \$4,214,111.00. The cost of this work will be charged to account 35304100-803200-61020.

**BACKGROUND:** On January 14, 2020, the Board of Commissioners approved a Master Plan for Lakewood Forest Preserve and authorized staff to proceed with the implementation of Phase I of the planned improvements. In anticipation of improvements such as roads, parking areas and trails, the clearing of select trees and vegetation is required. In addition, other trees will be harvested for future repurposing within the nature education area.

The project was advertised on November 19, 2020 and two bids were received. A summary of the bids received is listed below:

Homer Tree Service, Inc. Clean Cut Tree Service, Inc. Staff recommends that Homer Tree Service, Inc. be awarded the contract as the lowest responsible bidder. Work is anticipated to begin February 1, 2021 and be completed by June 11, 2021.
