**<u>RECOMMENDATION:</u>** Recommend approval of a Resolution approving a new Ten-year Institutional Plan for the Bess Bower Dunn Museum of Lake County.

**STRATEGIC DIRECTIONS SUPPORTED:** Organizational Sustainability; Communication, Education, and Outreach; Public Access and Connections

**FINANCIAL DATA:** No immediate impact.

**BACKGROUND:** The Lake County Forest Preserve District ("District") owns and operates the Bess Bower Dunn Museum of Lake County ("Museum"). The District Board of Commissioners has previously approved an Institutional Plan for the Museum, most recently in 2010. Such a document is a requirement of accreditation through the American Alliance of Museums.

The Museum's current Institutional Plan expired just prior to the closure and relocation of the Museum to Libertyville in 2016. Prior to closing, Museum staff spoke with staff at the American Alliance of Museums and they acknowledged that, given the timing of the relocation, it would be appropriate for the Museum to allow the current Institutional Plan to lapse and to create a new Institutional Plan once the Museum re-opened in 2018. Museum staff drafted the Institutional Plan attached to the attached resolution in 2018. However, approval was delayed until the District completed updating the *Excellence is in our Nature* strategic plan, which occurred in July 2020.

The Institutional Plan for the Museum aligns with the District's *Excellence is in Our Nature* strategic plan; it is organized around the three pillars of (i) Leadership, (ii) Conservation and (iii) People, and includes nine goals and twenty-eight tactics. The work plan to achieve these goals will be developed on an annual basis through the District's annual budget and staff goal-setting processes.

WHEREAS, from time to time the Institutional Plan needs to be updated to align with District operations and industry best practices; and

WHEREAS, the proposed Institutional Plan will be implemented by staff on an annual basis through the budget process and is intended to guide operations through 2030;
