SUBJECT: 2015 Invasive Plant Control Project at Middlefork Savanna Forest Preserve

RECOMMENDATION: Recommend approval of a Resolution awarding a Contract for the 2015 Invasive Plant Control Project at Middlefork Savanna Forest Preserve to Homer Environmental, LLC, Lockport, Illinois, in the Contract Price of \$28,500.00.

BACKGROUND: Middlefork Savanna contains some of the highest quality remnant plant communities and habitat restorations in Lake County. This project will expand the scope of previous projects to further control invasive species found at Middlefork Savanna. The project was advertised on December 8, 2014 and ten bids were received. Initially, two vendors, Homer Environmental, Inc. and Liberty Prairie Restoration, submitted equal bids for this project. Project and company references were checked for both vendors and found to be satisfactory. In order to recommend only one vendor for this project, the District's Purchasing Manager asked each low bidder to submit a revised, lower bid. Homer Environmental revised and lowered its bid to \$28,500.00, making it the sole low bidder for this project. The work of this project will be used as matching contributions to the recently acquired Chicago-Calumet Rivers Fund Grant.
