SUBJECT: 2015 District-Wide Invasive Plant Management

RECOMMENDATION: Recommend approval of a Resolution awarding a Contract for the 2015 District-Wide Invasive Plant Management to Liberty Prairie Restorations, LLC, Libertyville, Illinois, in the Contract Price of \$140,400.00.

BACKGROUND: Invasive plant management is the most time-consuming task faced by District crews, and is a significant challenge to habitat conservation. Management of invasive plants is necessary to improve and conserve habitat quality and species diversity on District properties throughout Lake County. In order to pursue this necessary and ongoing work by District staff, the District hires a contractor on an hourly basis to complete several projects to control herbaceous invasive plants.

This year's contract will include control of reed canary grass, common reed, teasel, crown vetch, exotic cattail, Japanese knotweed, leafy spurge, Oriental bittersweet, spotted knapweed, fig buttercup and common goldenrod. The following sites are anticipated to be treated: Captain Daniel Wright Woods, Cuba Marsh, Fort Sheridan, Gander Mountain, Grainger Woods, Grant Woods, Greenbelt, Lake Carina, Lakewood, Lyons Woods, Raven Glen, Rollins Savanna, Edward L. Ryerson (Welcome Center), Van Patten Woods, Pine Dunes, MacArthur Woods, Tanager Kames and Wadsworth Savanna Forest Preserves.

The project was advertised on December 8, 2015 and nine (9) bids were received. A summary of the bids received is listed below:

Section 1: Recitals. The recitals set forth above are incorporated as part of this Resolution by this reference.

Section 2: Award of Contract. The bid submitted by Liberty Prairie Restorations, LLC, in the amount of \$140,400.00 (the "Contract Price") is hereby accepted and a Contract for the Work is hereby awarded to Liberty Prairie Restorations, LLC.

Section 3: Execution of Contract. The Executive Director of the District is hereby authorized and directed to execute the Contracts in the amounts of the Contract Prices.

Section 4: Payments. The District Treasurer shall make payments under the Contracts only pursuant to and in accordance with the Contracts' terms.

Section 5: Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
