SUBJECT:	District-Wide Alarm Monitoring, Maintenance, Repair and Testing Services

<u>RECOMMENDATION</u>: Recommend approval of a Resolution authorizing negotiation and award of a Contract for the performance of alarm monitoring, maintenance, repair, and testing Services to Sentry Security Group, LLC, of Wheeling, Illinois.

BACKGROUND: The District issued a Request for Proposals on January 30, 2015 to provide solutions for alarm monitoring, maintenance, repair, and testing services at 16 locations within the District. Sentry Security Group, LLC was among the three firms that submitted proposals for consideration. The District's evaluation team, consisting of four staff members from the Facilities, Public Safety, Operations and Infrastructure and Administration departments, evaluated all of the proposals and have determined that Sentry Security Group, LLC would be the best choice to meet the District's needs.

Their proposal meets the District's specifications regarding monitoring, maintenance, repair, and testing. Staff is seeking approval to negotiate and approve a final contract for the performance of these services. The contract would have a two-year term with the option to renew the contract for three, one-year renewal terms.

<u>REASON FOR RECOMMENDATION:</u> Committee recommendation and Board approval are required in accordance with the District's Purchasing Policy.

A RESOLUTION AWARDING A CONTRACT TO SENTRY SECURITY GROUP, LLC, FOR ALARM MONITORING, MAINTENANCE, REPAIR, AND TESTING SERVICES

WHEREAS, the Lake County Forest Preserve District (the "District") desires to purchase alarm monitoring, maintenance, repair, and testing services (the "Services"); and

WHEREAS, the Director of Administration, and the Purchasing Manager have determined that the Services require personal confidence; and

WHEREAS, the Purchasing Manager has solicited proposals for the Services; and

WHEREAS, the District's staff, the Purchasing Manager, the Director of Administration, and the Finance and Administrative Committee have reviewed the proposals and recommend that the Board of Commissioners (i) find that the proposal submitted by Sentry Security Group, LLC, be determined to be the proposal that is most advantageous to the District; and (ii) award a two-year contract, with the option to renew for three, one-year renewal terms, for the Services to Sentry Security Group, LLC (the "Contract") in the amounts set forth in the schedule of prices attached hereto and made a part hereof as Exhibit A (the "Contract Price"); and

WHEREAS, the Board of Commissioners hereby finds that the proposal for the Services submitted by Sentry Security Group, LLC, is the proposal that is most advantageous to the District;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:

<u>Section 1</u>: <u>Recitals</u>. The recitals set forth above are incorporated as a part of this Resolution by this reference.

<u>Section 2</u>: <u>Award of Contract</u>. The Executive Director (or his designee) is hereby authorized to negotiate the Contract in the amount of the Contract Price, provided that the Contract shall require Sentry Security Group, LLC, to provide Services to the District for an initial term of two years, with the option to renew the Contract for three one-year renewal terms, and in accordance with the specifications set forth in the District's request for proposals.

Section 3: Execution of Contract. After completion of such negotiations, the Contract shall be awarded to Sentry Security Group, LLC. The Executive Director of the District is hereby authorized and directed to execute the Contract for the Services in the amount of the Contract Price.

Section 4: Payments. The District Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.

<u>Section 5</u>: <u>Effective Date</u>. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
