Hydrologic Analysis and Design Services at Middlefork Savanna Forest Preserve

<u>RECOMMENDATION</u>: Approve a Resolution awarding a contract for hydrologic analysis and design services at Middlefork Savanna Forest Preserve to Hey and Associates, Inc. of Volo, Illinois, in the Contract Price of \$27,800.00.

BACKGROUND: In 2014 the District applied for and was awarded grant monies from the Chicago-Calumet Rivers Fund. The Fund supports restoration work within the Chicago and Calumet River watersheds in the greater Chicagoland area. Hey and Associates will provide hydrologic analysis and design services to the District to aid in wetland restoration activities connected to this grant, including land surveying, wetland delineation, analysis of existing conditions, design for wetland restoration (removal of agricultural drain tile, installation of water control structures, coordination of work across property boundaries) and obtaining required permits from the Lake County Stormwater Management Commission and US Army Corps of Engineers. This project will expand the scope of previous projects to further manage and enhance natural habitats at Middlefork Savanna. The work of this project will be used as matching contributions for the Chicago-Calumet Rivers Fund Grant.

Staff recommends that Hey and Associates, Inc. of Volo, Illinois be awarded the contract as they are a professional service contractor skilled in this type of project. Work is anticipated to begin in March 2015 and be completed in 2016.

REASON FOR RECOMMENDATION: Committee recommendation and Board approval are required in accordance with District policy.

<u>FINANCIAL DATA</u>: This project was approved as part of the adopted FY 2014/2015 Capital Improvement Plan for Habitat Restoration in the amount of \$500,000.00. This portion of the project was estimated at \$30,000.00. The actual cost of \$27,800.00 will be charged to the Habitat Restoration Fund (201041000-803200-60004).

A RESOLUTION AWARDING A CONTRACT TO HEY AND ASSOCIATES, INC., FOR HYDROLOGIC ANALYSIS AND DESIGN SERVICES AT MIDDLEFORK SAVANNA FOREST PRESERVE

WHEREAS, the Lake County Forest Preserve District (the "District") desires purchase hydrologic analysis and design services (the "Services")at the Middlefork Savanna Forest Preserve; and

WHEREAS, the Director of Natural Resources and the Purchasing Manager have determined that the Services require personal confidence; and

WHEREAS, the Purchasing Manager has solicited a proposal for the Services; and

WHEREAS, the District's staff, the Purchasing Manager, the Director of Natural Resources, the Planning and Restoration Committee, and the Finance and Administrative Committee have reviewed the proposal and recommend that the Board of Commissioners (i) find that the proposal submitted by Hey and Associates, Inc., be determined to be the proposal that is most advantageous to the District; and (ii) award a contract for the Services to Hey and Associates, Inc., (the "Contract") in the amount of \$27,800.00 (the "Contract Price"); and

WHEREAS, the Board of Commissioners hereby finds that the proposal for the Services submitted by Hey and Associates, Inc., is the proposal that is most advantageous to the District, and that the Contract Price is fair and reasonable; and

WHEREAS, the District has a satisfactory relationship with Hey and Associates, Inc., for hydrologic analysis and design services;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois THAT:

Section 1. Recitals. The recitals set forth above are incorporated as a part of this Resolution by this reference.

<u>Section 2</u>. <u>Award of Contract</u>. The Contract for the Services in the amount of the Contract Price, in substantially the form attached hereto, is hereby awarded to Hey and Associates, Inc.

<u>Section 3</u>. <u>Execution of Contract</u>. The Executive Director of the District is hereby authorized and directed to execute the Contract for the Services in the amount of the Contract Price.

<u>Section 4</u>. <u>Payments</u>. The Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.

<u>Section 5</u>. <u>Effective Date</u>. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
