**SUBJECT:** Des Plaines River Trail – Ryerson North Construction

**RECOMMENDATION:** Recommend approval of a Resolution awarding a Contract for the Des Plaines River Trail-Ryerson North Construction to Campanella and Sons, Inc., Wadsworth, Illinois in the Contract Price of \$839,137.60.

<u>BACKGROUND</u>: On July 15, 2014, the Board approved the acquisition of a 4.4-acre addition to the Edward L. Ryerson Conservation Area (Boznos Parcel). The acquisition allows for the completion of a 0.3-mile section of the Des Plaines River Trail. The following August, the Board approved a contract with Pearson Brown Associates, Inc. for engineering services for the design, permitting and construction documents for the project.

The project includes vegetation removal, grading, sheet pile retaining wall, drainage systems, asphalt paving, custom fencing, seeding and erosion control measures required to complete the last remaining section of the Des Plaines River Trail.

The project was advertised on April 10, 2015 and five (5) bids were received. A summary of the bids received is listed below, and includes one bid alternate amount:

Staff recommends that Campanella and Sons be awarded the contract as the lowest responsible bidder. Work is anticipated to begin in June 2015 and be completed by September 2015.

**FINANCIAL DATA:** This project was approved as part of the adopted FY 2014/2015 Capital Improvement Plan in the amount of \$704,090.00 and part of the anticipated adoption of the FY 2015/16 Capital Improvement Plan in the amount of \$300,000.00. This portion of the project was estimated at \$950,000.00. The actual cost of \$839,137.60 will be charged to account 35634100-803200-63302 (\$547,568.00) and account 20104100-803200-63302 (\$291,569.60).
