**RECOMMENDATION:** Recommend approval of a Resolution awarding a Contract to Sutton Ford Inc. in the Contract Price of \$59,243.00 for the purchase of a 2025 Ford F150 Lightning PRO CC 4x4 Pickup Truck.

**STRATEGIC DIRECTION SUPPORTED:** Organizational Sustainability.

**FINANCIAL DATA:** The adopted FY2025 Budget for the Vehicle Replacement Fund is \$721,000.00, including an estimated \$68,000.00 for this vehicle. The actual cost of \$59,243.00 will be charged to the Vehicle Replacement fund, account 90104100-804000. The annual user charge will be calculated based on the actual total purchase price.

**BACKGROUND:** In accordance with the District's equipment replacement guidelines, staff has determined previously that a 2014 Chevrolet 1500 Silverado pickup (Unit 137) is due to be replaced.

As part of staff's ongoing evaluation of vehicle replacements in accordance with the District's Green Fleet Policy, staff has determined that the Ford F150 Lightning is the most fuel-efficient vehicle available that will meet the District's needs.

Pursuant to the Illinois Governmental Joint Purchasing Act, 30 ILCS 525/1, et seq., any governmental unit may purchase personal property, supplies, and services jointly with one or more other governmental units, as provided in the Act. Staff determined that the Ford F150 Lightning is available under the State of Illinois Joint Purchasing Master Contract 24-416CMS-BOSS4-P-63043 with Sutton Ford Inc.

The new vehicle will be utilized by the Natural Resources Department and housed at the Operations and Public Safety Facility.

The new vehicle is expected to be in service for 10 years per the vehicle replacement guidelines.

**WHEREAS**, the Lake County Forest Preserve District (the "District") desires to purchase one 2025 Ford F-150 Lightning pickup truck, or approved equivalent, for use by the Natural Resources Department (the "Vehicle"); and

**WHEREAS**, pursuant to the Illinois Governmental Joint Purchasing Act, 30 ILCS 525/1, et seq., any governmental unit may purchase personal property, supplies, and services jointly with one or more other governmental units if one of the governmental units has publicly advertised for, and received, competitive, sealed bids or proposals, and has awarded a contract for such personal property, supplies, and services to the lowest responsible bidder or the highest ranking proposer, all in accordance with such Act; and

**WHEREAS**, the Illinois Department of Central Management Services ("CMS") has publicly advertised for, and received, competitive sealed bids for a contract for the Vehicle, including a bid from Sutton Ford Inc.; and

**WHEREAS**, the CMS has awarded a contract (24-416CMS-BOSS4-P-63043) for the Vehicle to Sutton Ford Inc. as the lowest responsible bidder (the "CMS Contract"), and the CMS Contract provides that other units of local government may also enter into contracts with Sutton Ford Inc. on the same terms as provided in the CMS Contract; and

**WHEREAS**, it is in the best interest of the District to award a contract for purchase of the Vehicle to Sutton Ford Inc. on the same terms as provided in the CMS Contract (the "Contract") in a total price of \$59,243.00 (the "Contract Price");

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, THAT:

**Section 1: Recitals.** The recitals set forth above are incorporated as part of this Resolution by this reference.

**Section 2: Award of Contract.** The bid submitted by Sutton Ford Inc. for the Vehicle in the total amount of the Contract Price is hereby accepted, and a Contract for the Vehicle is hereby awarded to Sutton Ford Inc. in the amount of the Contract Price.

**Section 3: Execution of Contract.** The Executive Director of the District is hereby authorized and directed to execute the Contract with Sutton Ford Inc.

**Section 4: Payments.** The Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.

**Section 5: Effective Date.** This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
