RECOMMENDATION: Recommend approval of a Resolution awarding Contracts for Plant Protectant and Herbicide Products to Advanced Turf Solutions, Inc.; Carlin Sales Corporation; BTSI; Clesens Inc.; Conserv FS; Pendelton Turf Supply; Reinders, Inc; SiteOne Landscape Supply; Simplot AB Retail, Inc.; Van Diest Supply Company; Nutrien AG Solutions; and Heritage Landscape Supply Group, Inc. in a total amount not to exceed \$529,500.00.

STRATEGIC DIRECTIONS SUPPORTED: Organizational Sustainability; Conservation

FINANCIAL DATA: The District's approved FY2025 budget provides for payment for these products with \$101,000.00 in the Natural Resources Grounds Maintenance Supplies account (27643800-641100) and \$428,500.00 in the Golf Grounds Commodities account. Specific account codes are shown on Appendix A to this memorandum.

BACKGROUND: These products are purchased annually and used on an as-needed basis to maintain the golf courses and provide the needed herbicide applications on other District properties. Each yellow highlighted bid listed on the Exhibit is the lowest responsible bid for the corresponding type of product (assuming the Board allows the withdrawal of the Incorrect Bids, defined below). The bids highlighted in red on the Exhibit (the "Non-Conforming Bids") do not conform to the bidding specifications because they include unacceptable alternate products or container sizes that would result in a purchase of excess product. The bids highlighted in blue on the Exhibit (the "Incorrect Bids") are low bids that the vendors are asking to withdraw –because they reportedly reflect old prices from 2024 that the bidders state they will no longer be able to hold during the terms of the proposed Contracts. The staff recommends that the Board: (i) reject the Non-Conforming Bids, and (ii) allow the vendors to withdraw the Incorrect Bids.

**A RESOLUTION AWARDING CONTRACTS FOR THE PURCHASE OF
PLANT PROTECTANT AND HERBICIDE PRODUCTS**

WHEREAS, the Lake County Forest Preserve District (the "District") has advertised in The Lake County News Sun for sealed bids to purchase plant protectant and herbicide products, which are listed under the column titled "PRODUCT DESCRIPTION" on the attached exhibit (the "Products"); and

WHEREAS, all sealed bids were received and opened by the District at its General Offices, 1899 West Winchester Road, Libertyville, Illinois on January 30, 2025 at 11:00 a.m., and such bids are summarized on the exhibit attached hereto (the "Exhibit"); and

WHEREAS, the bids highlighted in blue on the Exhibit (the "Incorrect Bids") are low bids that the bidders have asked to withdraw, because such bids reflect prices that such bidders state they are unable to hold during the terms of the proposed Contracts (defined below); and

WHEREAS, the Board of Commissioners hereby finds that the red highlighted bids in the Exhibit are for incorrect or unacceptable alternate products, container sizes, or units of measure that do not conform to bidding specifications for the Products (collectively, the "Non-Conforming Bids"); and

WHEREAS, the District's staff, the Purchasing Manager, the Director of Golf Operations, the Director of Natural Resources, the Operations Committee, and the Finance Committee have reviewed the bids and recommend that the Board of Commissioners: (i) find that each yellow highlighted bid listed on the Exhibit (collectively, the "Low Bids") is a lowest responsible bid for the corresponding type of Product listed in the "PRODUCT DESCRIPTION" column of the Exhibit and (ii) award contracts for the Products to each of Advanced Turf Solutions, BTISI, Carlin Sales Corporation, Clesens Inc., Conserv FS, Heritage Landscape Supply Group, Inc., Nutrien AG Solutions, Pendelton Turf Supply, Reinders Inc., Simplot AB Retail Inc., SiteOne Landscape Supply, and Van Diest Supply (collectively the "Low Bidders") for the Products for which each Low Bidder submitted the Low Bid, pursuant to which the District may purchase such amounts of the Products that it determines are necessary or desirable for District use (the "Contracts"); and

WHEREAS, the Board of Commissioners hereby finds that each Low Bid is a lowest responsible bid for the corresponding type of Product listed in the "PRODUCT DESCRIPTION" column of the Exhibit;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois THAT:

Section 1. Recitals. The recitals set forth above are incorporated as a part of this Resolution by this reference.

Section 2. Approval of Withdrawal of Incorrect Bids. The withdrawal of the Incorrect Bids is hereby approved.

Section 3. Rejection of Non-Conforming Bids. The Non-Conforming Bids are hereby rejected.

Section 4. Acceptance of Low Bids and Award of Contracts. The Low Bids in the amounts listed on the Exhibit (the "Contract Prices") are hereby accepted, and Contracts for the Products are hereby awarded to the Low Bidders.

Section 5: Execution of Contracts. The Executive Director of the District is hereby authorized and directed to execute the Contracts for the Products in the amounts of the Contract Prices.

Section 6. Payments. The Treasurer shall make payments under the Contracts only pursuant to and in accordance with the Contracts' terms.

Section 7. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
