**RECOMMENDATION:** Recommend approval of a Resolution Approving Change Order No. 1 to the Contract with The Strategic Advocacy Group, LLC for legislative consulting services, increasing the Contract Amount by an amount not to exceed \$33,121.00.

**STRATEGIC DIRECTION SUPPORTED:** Organizational Sustainability

**FINANCIAL DATA:** The cost of these services will be charged to the Community Engagement and Partnerships line item for legislative expenses (11354000-706800). That account is budgeted for \$29,000.00 in FY2025. The total revised contract amount will be \$61,446.00.

**BACKGROUND:** In December 2024, District staff engaged the services of The Strategic Advocacy Group, LLC (“Consultant”) to provide state legislative consulting services for the calendar year 2025. The original contract was for services including assisting staff with strengthening relationships with state legislators, advocating for or against state legislation that may impact the District, and advancing the District’s state legislative priorities.

With the change in federal administration in early 2025 and the uncertainty around federal grant funding, District staff recommends increasing the scope and timeline of the contract with the Consultant to incorporate legislative consulting support at the federal level. This change order will extend the term of the contract through May 31, 2026 and increase the cost of services by \$31,121.00, adding the following deliverables:

- Help develop stronger relationships with federal elected officials and their staff.
- Schedule, plan, and participate in meetings with federal elected officials and their staff.
- Help develop and execute education efforts with federal elected officials and their staff.
- Advise District leadership and staff on strategies to achieve federal policy priorities.

In addition, the District will reimburse the Consultant for expenses related to out-of-state travel at cost and in an amount not to exceed \$2,000.00.

**WHEREAS**, as of December 30, 2024, the Lake County Forest Preserve District (the “District”) and Strategic Advocacy Group, LLC (the “Consultant”) entered into a contract (the “Contract”) for Legislative Consulting Services (the “Services”); and

**WHEREAS**, the District desires to increase the final Contract price by an amount not to exceed \$ 33,121.00 for additional Services to the District (the “Additional Services”), all as provided in Change Order No. 1 attached hereto (“Change Order No. 1”);

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:

**Section 1. Recitals.** The recitals set forth above are incorporated as a part of this Resolution by this reference.

**Section 2. Approval of Change Order No. 1.** Change Order No. 1, in substantially the form attached hereto, is approved for the following reasons:

- a. The circumstances necessitating the Change Order were not reasonably foreseeable at the time the Contract was signed; and
- b. The Change Order is germane to the Contract, as signed; and
- c. The Change Order is in the best interest of the District and is authorized by law.

**Section 3. Placement in Contract File.** This resolution and Change Order No. 1 shall be preserved in the permanent District file of the Contract. This Resolution shall constitute the written determination required by Section 33E-9 of the Illinois Criminal Code, 720 ILCS 5/33E-9.

**Section 4. Effective Date.** This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
